#### AMENDMENT NUMBER 1 TO MEMORANDUM OF UNDERSTANDING BETWEEN THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY AND THE TENNESSEE GOLF FOUNDATION

This Amendment is entered into on this the \_\_\_\_\_ day of \_\_\_\_\_, 2014, by and between The Metropolitan Government of Nashville and Davidson County ("Metropolitan Government") and the Tennessee Golf Foundation ("TGF").

#### WITNESSETH

WHEREAS, Ordinance BL99-74 approved a Memorandum of Understanding ("Agreement") between the Metropolitan Government and TGF; and,

WHEREAS, the Agreement authorized TGF to build, at its expense, a facility in Shelby Park consisting of a nine-hole golf course, a clubhouse, and a driving range for the Metropolitan Government and to establish an ongoing program devoted to providing opportunities for young people in Davidson County to learn and play golf; and,

WHEREAS, the parties desire to modify certain terms and conditions of the Agreement.

NOW, THEREFORE, in consideration of the promises and mutual covenants contained herein, the parties hereby agree as follows:

I. Section 1, "Term," is hereby amended by deleting the following sentence:

"The Agreement may be extended for an additional term of ten (10) years by consent of the parties."

And replacing it with the following sentence:

"The Agreement may be extended for two additional terms of ten (10) years each by consent of the parties."

II. Section 2, "Facility Construction and Acceptance" is hereby amended by adding the following sentence:

"In the event that the Metropolitan Parks Department experiences a budget reduction for golf course maintenance, the golf facilities will be impacted proportional to budgetary restrictions, and the Metropolitan Government will provide maintenance for the golf facilities comparable to the maintenance performed on other golf courses under the jurisdiction of the Metropolitan Board of Parks and Recreation."

### AMENDMENT NUMBER 1 TO MEMORANDUM OF UNDERSTANDING BETWEEN THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY AND THE TENNESSEE GOLF FOUNDATION

III. Section 3, "Operations Funding," is hereby amended by adding the following sentence:

"Effective January 1, 2015, TGF will be responsible for all inside Facility staffing costs."

- IV. Section 4, "Revenues," is hereby amended by adding the following language: "Effective January 1, 2015, TGF shall be entitled to all revenues collected at the site including programming activities as defined in this Agreement, all food, drink, and merchandise sales, and all green fees and driving range fees. Any green fee increase is subject to prior approval of the Metropolitan Board of Parks and Recreation."
- V. All terms set forth in the Agreement approved by Ordinance BL99-74 shall remain in full force and effect, except to the extent such terms are superseded or modified by the provisions of this Amendment, in which case this Amendment will prevail. This Amendment shall not be binding upon the parties until it is approved by the Metropolitan Council.

# BOARD APPROVES CONTRACT FOR MANAGEMENT OF AMPHITHEATER LOCATED IN WEST RIVERFRONT PARK

Upon motion of Ms. Smith, seconded by Mr. Fossick, board approved contract with Live Nation for management of amphitheater in West Riverfront Park once the park is completed. This contract will now be sent to the Metro Council and will have to pass three readings before it will be realized. Mr. Peter Heidenriech was present representing Live Nation. Management Agreement Summary follows:

# **Amphitheater Management Agreement Summary**

- Contractor: Live Nation Worldwide, Inc.
- Contract Term: 125 months, beginning August 1, 2015
- Live Nation will pay Metro \$400,000 per year, plus a portion of ticket and concession sales.
- Live Nation will build and pay for some enhancements to the amphitheater at a cost of \$1.5 \$1.75 million.

# BOARD APPROVES CONTRACT FOR MANAGEMENT OF AMPHITHEATER LOCATED IN WEST RIVERFRONT PARK

### **Amphitheater Management Agreement Summary**

- Metro has the right to use the Amphitheater for the CMA festival, plus July 4 and December 31, as well as seven other "Civic Events" per year at Metro expense.
- The Nashville Symphony will be able to use the Amphitheater under separate agreement with Live Nation.
- Metro to control scheduling of activities with the park surrounding the Amphitheater.
- Live Nation has naming rights, within usual Metro limits.
- Metro has the right to approve the size and location of all signs to be affixed to the Amphitheater.
- Live Nation is responsible for securing and maintaining the Amphitheater, with Metro to mow and maintain the grassy areas.
- Live Nation is responsible for operating costs and is entitled to retain most revenues generated by operating the Amphitheater.
- Live Nation to make quarterly reports on the Amphitheater to the Parks Board.

# XIV. REPORT OF THE DIRECTOR (con't.)

- The dedication of the 46th Avenue and Murphy Road Roundabout and Streetscaping Project is scheduled for November 17th. He stated that the completion of paving the golf course parking lot should be completed on November 4 and the greenway connection will be completed before the dedication.
- What will happen to the vacated Sounds Stadium in Fort Negley Park after they move to their new playing location will be decided at that time as we have been approached by different groups for utilization of the facility.
- Met with the reps of the Guns of Fort Negley after their September reenactment to inform them that Metro Parks will revisit policies with regard to events held at Fort Negley. Metro Parks' policies will be amended to be defined and consistent with both State and Federal agencies.
