OF A MULTI-YEAR LICENSE FOR USE OF RIVERFRONT PARK
FROM THANKSGIVING TO NEW YEAR'S EVE**

COMMISSION TO BRAND THE URBAN GREENWAY CORRIDOR SYSTEM
CITY CENTRAL GREENWAY**

Upon motion of Dr. Brannon, seconded by Mr. Haynes, the board approved the request of staff and the Open Space Commission and in keeping with the department's current standard for geographically naming greenways, the system created by these urban greenway corridors be collectively branded City Central Greenway, with individual segments and trailheads being identified with nearby streets and physical landmarks as outlined in Plan to Play. This simple and consistent way finding convention based on geography for greenway trails contributes significantly to usability and public awareness, interest and safety.

BOARD APPROVES REQUEST FROM STAFF AND THE OPEN SPACE COMMISSION TO BRAND THE URBAN GREENWAY CORRIDOR SYSTEM CITY CENTRAL GREENWAY

Metro's waterway-based greenways are identified geographically according to the waterway they follow and the physical location of a particular trailhead along that route. New urban greenway priority corridors were identified in Plan to Play. These include the Downtown loop, North Gulch to Bicentennial Mall, South Gulch to South Street, Charlotte Rail Trail to 440, Mid-Town Loop, 440 Greenway and Brown's Creek to Fairgrounds to Cumberland River / Rolling Mill Hill / Riverfront Park. Together these corridors create a system around the city's urban center.

BOARD APPROVES REQUEST FROM STAFF TO NAME METRO PARKS PROPERTY LOCATED AT 3401 CENTRAL PIKE, RAVENWOOD PARK

Upon motion of Mr. Fossick, seconded by Dr. Brannon, the board approved staff request to name Metro Parks' property known as Ravenwood and located at 3401 Central Pike, parcel 085000021700, as Ravenwood Park.

During a master planning process in 2017, Metro Parks utilized the title Stones River Bend to collectively refer to contiguous properties that consist of Stone Hall Park, Lytle Park and the former Ravenwood County Club property. Only the latter property does not currently have an official name.

Through the course of master planning and since, there have been numerous community discussions about possible names for the park. Popular potential names have included Stones River Bend Park, Stones River Park, Riverbend Park and Ravenwood Park.

The subject property includes Stones River frontage, but it does not include a river bend. It is the adjacent Lytle tract that is defined by a river bend.

The Ravenwood property was purchased by Metro Parks from the Ravenwood Country Club organization. The country club and golf course were named for the Ravenwood estate and country house. Sarah Dodson DeBow and her husband Judge James Dunwoody Brownson DeBow developed a two-story stone mansion on the site in the early 20th Century. Sarah named the estate Ravenwood due to the large number of ravens present on the site. Stone entry monuments and terraces from the estate remain on the property today. This property is commonly referred to in the community and beyond as Ravenwood.

PUBLIC ART ON THE EXTERIOR WALL OF ELIZABETH PARK SENIOR CENTER**

Ms. Simone Boyd, representing the organization, District 21 Neighbors, appeared before the board requesting approval to install a temporary piece of public art in the exterior wall of the Elizabeth Park Senior Center located at 1701 Arthur Avenue.

Dr. Brannon stated that her term on the School Board expires in August and she is not running again after serving for 12 years. She said this would be her final Parks Board meeting as her term expires June 30 and she has really enjoyed her time with the board.

With there being no further business, the meeting was adjourned.
