BOARD ACCEPTS DONATION OF 1,000 TREES VALUED AT \$200,000 FROM THE CUMBERLAND RIVER COMPACT

Correspondence received from Ms. MeKayle Houghton, representing The Cumberland River Compact, on behalf of Root Nashville, requesting the board to accept 1,000 trees, valued at \$200,000, to be planted at Ravenwood Park was presented to the board for approval.

Upon motion of Mr. Fossick, seconded by Dr. Gentry, the board accepted a donation of 1,000 trees, valued at \$200,000, to be planted at Ravenwood Park. Ms. Houghton explained that Root Nashville is a campaign to restore Nashville's urban tree canopy by planting 500,000 trees in Nashville by 2050 and this campaign is endorsed by Mayor Briley's Office and supported by Martin Brown and his family, Nissan North America, Nashville Health, and Senator Bill Frist.

Trees planted as part of this campaign will be at least 1" caliper and 6-8 feet tall. The species will be selected by Metro Parks and consistent with the Ravenwood Park Master Plan, procured in McMinnville, Tennessee and planted by Tennessee Tree and Shrub. The Cumberland River Compact will pay for the trees, their planting and first two years of watering with Root Nashville funds.

BOARD DEFERS NAMING REQUESTS OF THE MIRACLE FIELD OF MUSIC CITY AS PER PARK POLICY 3000.1

As per Parks Board policy, the board deferred the request of Mr. Scott Tygard, representing the Miracle Field of Music City, as per board policy 3000.1. Mr. Tygard requested board approval of the following naming rights:

- The MLMC requests permission for the naming rights to the Complex of the Miracle Field of Music City to be named "The Miles for Miles Foundation Miracle Field Complex of Music City." The Complex consists of the playing field area, the concession stand area, fan area, bathrooms and the playground. The Miles for Miles Foundation is a nonprofit 501©3 located here in the Middle Tennessee area and helps in funding programs for Downs Syndrome families. In exchange for the naming rights to the MLMC complex, the Miles for Miles Foundation has pledged \$350,000 to the MLMC and is ready to write a check ASAP.
- The MLMC requests permission for the naming rights to the Miracle Field itself to be named "The More Than Me Foundation Miracle Field of Music City Field." The field consists of the Miracle Field itself. The More than Me Foundation is a 501©3 nonprofit and consists of MLB players, some of which are ex Vanderbilt baseball players, whose mission is to reach out and donate funds and volunteers to community efforts such as the MLMC. In exchange for the naming rights to the MLMC field, the More than Me Foundation has pledged \$250,000 to the MLMC. Their fundraising for the \$250,000 is ongoing.

BOARD ACCEPTS DONATION OF GYMNASTICS EQUIPMENT AND FUNDS VALUED AT \$5,924.00 TO ESTABLISH A YOUTH GYMNASTICS PROGRAM AT MADISON RECREATION CENTER

Upon motion of Ms. Hughes, seconded by Mr. Fossick, the board accepted a donation of gymnastics equipment and funds valued at \$5,924.00 from VP Tumbl Trak, American Gymnast, Flip Fest Gymnastics Camp and USAG Gymnastics TN to establish a youth gymnastics program at Madison Recreation Center. Donated funds and equipment were sought out by Recreation Leader, Rachel Wahlstrom.

Rachel Wahlstrom started gymnastics when she was 5. She continued into competitive gymnastics and placed 4th all around at the Eastern National Gymnastics Competition. Competing took a major toll on her body and she underwent 11 surgeries. She decided it would be better to coach gymnastics after this. She graduated from the University of Tennessee at Chattanooga with a bachelor's in Sports Management & Administration, minoring in Promotions. She hit the ground running when she started as a Recreation Leader at Madison Community Center in August of 2018 and has accrued many donations to start her gymnastics classes at Madison Community Center. She is very eager, full of great ideas, and is a very integral member of the Madison team.

BOARD ACCEPTS DONATION OF 25 TREES VALUED AT \$3500.00 FROM THE CUMBERLAND RIVER COMPACT

Upon motion of Mr. Fossick, seconded by Ms. Hughes, the board accepted a donation of 25 trees, valued at \$3500.00, from the Cumberland River Compact to be planted along the 440 Greenway as part of the Root Nashville program. Please note that the value of the trees was amended by Ms. Cindy Harrison from \$1500.00 to \$3500.00 as larger trees will now be planted.

Mayor David Briley launched Root Nashville, a campaign to plant and care for 500,000 trees across Nashville by 2050 in collaboration with private, nonprofit and philanthropic partners. The campaign is designed to increase the city's tree canopy and create a more equitable distribution of the health and sustainability benefits of urban trees across all neighborhoods. Parks Maintenance Landscape Division will manage the planting and watering during the grow-in period and has approved the proposed planting locations.

INTRODUCTION OF MS. KATIE PETROLE, EDUCATION DIRECTOR AT THE PARTHENON, TO THE BOARD

Ms. Wesley Paine, Director of the Parthenon, introduced Ms. Petrole to the board and provided the following information. Katherine (Katie) Petrole joins The Parthenon Museum as the Education Director after completing four years as the Steinmetz Family Foundation Museum Fellow at Corinth Excavations in Ancient Corinth, Greece.

For five years, Katie led archaeology and paleontology programming at The Children's Museum of Indianapolis, the largest children's museum in the world

She has completed numerous independent projects and internships from evaluating innovative art installations to cleaning and inventorying 3,500 marble sculptures at the Agora Excavations in Athens, Greece. In total, Katie spent six summers excavating and supervising museum projects at the Agora Excavations.

Recently, Katie was awarded J. M. Kaplan Fund Scholarships for Executive Leadership Development in exhibit development, natural and cultural heritage interpretation, and strategic planning. She has been named a Skype Global Learning Expert and Certified Microsoft Innovative Educator, and has been recognized with four other awards from the Microsoft Educator Community including the Microsoft Educator Community Influencer Award. She is a Certified Interpretive Guide with Interpret Europe.

Katie holds a BA in Classical Humanities from Miami University and a MA in Museum Studies from Indiana University in Indianapolis (IUPUI).

INTRODUCTION OF MS. HELEN SIEWERS, TECH SPECIALIST WITH THE GREENWAYS DIVISION, TO THE BOARD

Ms. Cindy Harrison, Assistant Director of Parks/Greenways, introduced Ms. Siewers, Tech Specialist with Greenways to the board. Helen Siewers is a Registered Landscape Architect and LEED Accredited Professional. She started with Metro Parks Nashville in January as Greenways Project Manager. Helen worked previously as Project Director with Cave Country Trails based in Mammoth Cave, Kentucky, as Campus Landscape Architect at Western Kentucky University, and Greenways Coordinator for Bowling Green and Warren County, Kentucky. Her first favorite park is Percy Warner Park in Nashville, TN, where she grew up.

MR. PHIL CLAIBORNE, REPRESENTING THE FRIENDS OF TWO RIVERS MANSION, PRESENTS ANNUAL UPDATE TO THE BOARD

Mr. Phil Claiborne introduced Ms. Mary Hart, 2019 President of the Board of the Friends of Two Rivers Mansion to the Parks Board. Mr. Claiborne reported that the 2018 budget was set at \$73,688; however, with an unexpected expense and revision of the budget because of the cancellation of The Evening of Elegance they completed 2018 on budget with a surplus of \$2,087.

The attendance numbers for events in 2018, including market visitors was 12,464, an increase of 1,899 over 2017. Halloween at the Mansion had an attendance of 4000+ the largest crowd to date.
