## MINUTES METROPOLITAN SEXUALLY ORIENTED BUSINESS LICENSING BOARD

The Sexually Oriented Business Licensing Board held a videoconference meeting via WebEx on July 8, 2020 at 4:00 p.m. Members Jonathan Richardson, Ashley Wood and Loren Russell were present. Members Cullen Earnest and Leneiva Head were absent. Attorney Justin Marsh and Inspector Christine Gibson were present. Chairman Jonathan Richardson called the meeting to order at 4:00 p.m.

Attorney Marsh stated, due to Executive Order 16, meetings for essential business of this Board be conducted in an electronic format and called for a motion to waive all rules to the contrary. Ms. Wood made the motion to waive all rules to the contrary. Mr. Russell seconded the motion and the Board voted unanimously.

Mr. Russell made the motion to approve the minutes for the meeting of March 11, 2020. Ms. Wood seconded the motion and the Board voted unanimously.

The meeting for March 25, 2020 was canceled; therefore, the following new entertainer permit applications from March 12, 2020 to March 25, 2020 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): No applications. In addition, the following renewal entertainer permit applications were approved: 2177, 2786, 2797 and 2934. There were no new or renewal business applications during this time period.

The meeting for April 8, 2020 was canceled. There were no new or renewal permit applications from March 26, 2020 to April 8, 2020. There were no new or renewal business applications during this time period.

The meeting for April 22, 2020 was canceled. There were no new or renewal permit applications from April 9, 2020 to April 22, 2020. There were no new or renewal business applications during this time period.

The meeting for May 13, 2020 was canceled. There were no new or renewal permit applications from April 23, 2020 to May 13, 2020. There was no new business application during this time period. Pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2), #2646, Déjà vu of Nashville, was approved.

The meeting for May 27, 2020 was canceled; therefore, the following new entertainer permit applications from May 14, 2020 to May 27, 2020 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): No applications. In addition, the following renewal entertainer permit applications were approved: 1199, 1234 and 2999. There were no new or renewal business applications during this time period.

The meeting for June 10, 2020 was canceled; therefore, the following new entertainer permit application from May 28, 2020 to June 10, 2020 was approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3146. Mr. Russel made the motion to approve the permits. Ms. Wood seconded the motion and the Board voted unanimously. Ms. Gibson informed the Board there were no new or renewal business applications during this time period.
