

MINUTES
METROPOLITAN SEXUALLY ORIENTED
BUSINESS LICENSING BOARD

The Sexually Oriented Business Licensing Board held a videoconference meeting via WebEx on October 28, 2020 at 4:00 p.m. Members Jonathan Richardson, Cullen Earnest, Leneiva Head, Ashley Wood and Loren Russell were present. Attorneys Derrick Smith and Matthew Garth and Inspector Christine Gibson were present. Chairman Jonathan Richardson called the meeting to order at 4:05 p.m.

Mr. Richardson stated, due to Executive Order 16, meetings for essential business of this Board be conducted in an electronic format and called for a motion to waive all rules to the contrary. Ms. Wood made the motion to waive all rules to the contrary. Mr. Earnest seconded the motion and the Board voted unanimously.

Ms. Head made the motion to approve the minutes for the meeting of July 8, 2020. Mr. Russell seconded the motion and the Board voted unanimously.

The meeting for July 22, 2020 was canceled; therefore, the following new entertainer permit applications from July 9, 2020 to July 22, 2020 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3151, 3152, 3153, 3154, 3155 and 3156. In addition, the following renewal entertainer permit applications were approved: 1213, 2274, 2841, 2957 and 2982. There were no new or renewal business applications during this time period.

The meeting for August 12, 2020 was canceled; therefore, the following new entertainer permit applications from July 23, 2020 to August 12, 2020 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3157, 3158 and 3159. In addition, the following renewal entertainer permit applications were approved: 940, 2217, 2314, 2509, 2749, 3003, 3018 and 3031. There were no new business applications and #1605 Miranda's of Nashville, was approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2).

The meeting for August 26, 2020 was canceled; therefore, the following new entertainer permit applications from August 13, 2020 to August 26, 2020 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3160, 3161, 3162, 3163 and 3164. In addition, the following renewal entertainer permit applications were approved: 390, 1940, 2551, 2860, 2861, 3008 and 3023. There were no new or renewal business applications during this time period.

The meeting for September 9, 2020 was canceled; therefore, the following new entertainer permit applications from August 27, 2020 to September 9, 2020 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3165, 3166, 3167, 3168, 3169, 3170, 3171, 3172 and 3173. In addition, the following renewal entertainer permit applications were approved: 1954, 2128 and 3050. There were no new or renewal business applications during this time period.

The meeting for September 23, 2020 was canceled; therefore, the following new entertainer permit applications from September 10, 2020 to September 23, 2020 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3174, 3175, 3176, 3177 and 3178. In addition, the following renewal entertainer permit applications were approved: 2383, 2512, 2546, 2659, 2671, 2719, 2888 and 3074. There were no new or renewal business applications during this time period.

The meeting for October 14, 2020 was canceled; therefore, the following new entertainer permit applications from September 24, 2020 to October 14, 2020 were approved pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2): 3180, 3181, 3182, 3183, 3184, 3185, 3186, 3187, 3188, 3189, 3190, 3191, 3192, 3193 and 3194. In addition, the following renewal entertainer permit applications were approved: 1280, 1385, 1700, 1715, 2118, 2127, 2224, 2614, 2780, 2851, 2858, 2859, 2880, 3022 and 3072. Also, pursuant to Metropolitan Code of Laws Section 6.54.070(C)(2), #3179, 822 5th Avenue South, LLC (D/B/A Larry Flynt's Hustler Club / Kings of Hustler) was approved. There was no renewal business application during this time period.

Ms. Gibson informed the Board that the following new entertainer permit applications were in order from October 15, 2020 to October 28, 2020: 3195, 3196, 3197, 3198, 3199, 3200 and 3201. Mr. Earnest made the motion to approve the permits. Ms. Head seconded the motion and the Board voted unanimously.

Ms. Gibson informed the Board that the following renewal entertainer permit applications were in order from October 15, 2020 to October 28, 2020: 429, 580, 944, 1125, 1416, 1788, 2387, 2553, 2560, 2728, 2737, 2829 and 3041. Mr. Earnest made the motion to approve the permits. Ms. Head seconded the motion and the Board voted unanimously. Ms. Gibson informed the Board there were no new or renewal business applications during this time period.

Ms. Gibson presented her Inspector's report to the Board. She advised that the following businesses were in compliance during regular inspections: Pure Gold's Crazy Horse, Déjà vu of Nashville, Jenna's Toy Box (Dickerson Road), Jenna's Toy Box (Gallatin Pike) and Lion's Den. Miranda's Nashville has closed and pursuant to Metropolitan Code of Laws Section 6.54.030, has relinquished their license.

This concluded their business. Ms. Head made the motion to adjourn. Ms. Wood seconded. The Board voted unanimously and adjourned at 4:25 p.m. until the meeting of November 11, 2020 at 4:00 p.m.
