Ms. Ronette Adams-Taylor seconded the motion. Ms. Adams-Taylor, Mr. Dobb Galbreath, Ms. Debra Grimes, Ms. Anna Maddox, and Mr. Sevier voted in favor of the motion. The motion carried.

- 1. This variance will expire on December 7, 2018. However, if a Grading Permit, Stormwater Single Family Permit, or Building Permit is issued within that period, the variance expiration date will run concurrent with that permit expiration date. The variance is valid only so long as the plan presented to the Stormwater Management Committee does not change.
- 2. The Appellant shall have the landscaper who installs the required mitigation plantings to certify to Ms. Kimberly Hayes, MWS Development Services, in writing (referencing Variance #201700030), once plantings are installed per approved variance plans, and again once plantings have been found to meet a two full growing season requirement. The owner shall maintain a minimum of 75 percent survivability of plantings through two full growing seasons.

PLANNING: Site is zoned OR20, the plans indicate previous pavers will be used to offset the impacts of the additional parking, minimal disturbance will occur in the required buffer area. Defer to Stormwater for review.

GREENWAYS: Greenways defers to SWMC.

The committee denied preliminary based on: 1) no justification, 2) site would be hardened by building a larger building on the site, and 3) encroachment into the zone 1 and zone 2 buffer.
