## Call to Order

Metro Arts Commission Chair Clay Haynes called the June meeting to order at 12:04PM.

## Minutes of previous meeting

A motion to approve minutes from May 18, 2017 was offered by Commissioner Keeton, seconded by Commissioner Coffman, and the motion passed.

## **Operations/Policy**

## Budget Update

Executive Director Jen Cole reported that Metro Arts budget passed. This includes a \$275,000 increase to the grants budget, and \$225,000 to Neighborhood Projects Improvements.

# • Branding Update

Cole also stated that the brand for Metro Arts will be updated and \$40,000 in a special purpose account will be utilized for a rebranding effort for the 40<sup>th</sup> Anniversary. DVL Seigenthaler has presented a scope of work for designing a brand architecture and bringing the visual brand in alignment to be rolled out during December. Commissioner Alvis, Commissioner Whitney, and Commission Tefel have been appointed as board representatives for the rebranding effort. Cole stated that kickoff discussions for the rebrand will be held in July.

Intern Syndey Lewis reported on the conditions assessment of Public Art. She stated a final report will be presented. Cole stated once the conditional analysis is complete, finding of conservation project will be explored by Metro Arts.

#### **Community Arts**

### FY18 Grants Allocations- ACTION

Grants Manager Laurel Fisher directed Commissioners to a Power Point that detailed FY18 Grant Allocations. The revised Grants Program included new Guidelines, new application, a monitoring aspect, and a new scoring rubric. Fisher reported a shift in the Basic 1 category; this year Watkins College of Art was not be eligible for operating support funding. This change shifted the category from six major arts institutions to five. The biggest shift occurred in the Basic 2 category, three new applicants entered the category. A slight shift in Basic 3 included three organizations entering the pool. With the new averaging revenue to determine eligibility, some organizations went down into the core support category.

Fisher noted an Arts Access to Youth Arts shift. Arts access received 12 applications totaling \$82,000 in requests; Youth Arts received 20 applications totaling \$127,000 in requests. In Youth Arts 7 of 20 applicants are not operating support grantees. In Arts Access 5 of 12 applicants are considered to be non-arts organizations. 8 applications reviewed, \$105,000 in requests were received for the new grant category, Catalyst as well as 8 applications reviewed for \$133,000 in requests in the creation category.

Fisher stated that the panel review focused on organizational health, programs and service to community. The rubric forced conversations about equity, inclusion and authentic partnerships and caused CEO's + Executive Directors to take notice of application material. It also revealed issues of governance, lack of diversity in leadership, and the absence of several organizational policies and procedures. Financial Review scores and comments were completed by professionals familiar with nonprofit financials.

Fisher presented the Allocation Philosophy. This year, in the Basic Operating pool, there was no divisions for Basic 1-3, rankings were honored, and right size award amounts were determined. The Core Operating support category provides foundation support for young and culturally specific NPOs. These organizations will be allowed re-evaluation in FY19. The project support category now rewards high quality project proposals, encourages innovation, and is disconnected from operating support award amounts.

There was discussion of organizations being inclusionary and diverse.

### Updates – Restorative Justice & the Arts, REAL, Opportunity NOW

#### • Restorative Justice

The training series has been completed and artists have submitted their revised ideas and budgets to start programming later in the spring. Nine projects are moving forward to date in various places within the system including Juvenile Detention, Gang Court, Youth Overcoming Drug Abuse, and several projects in neighborhoods.

## Opportunity NOW

Cole reported that beginning May 30, sixty-three youth (ages 14-16) led by local artists and 7 Near Peer Coaches will begin work readiness training that will result in participation in 6-week project-based work experiences that are centered in the arts.

#### REAL

The 2017 Cadre completed at the beginning of May. Metro Arts continues to work with Crossroads to look at our internal processes and practices in support of racial and cultural equity. Plans for the FY18 program are currently under development.

## **Public Art**

### Project Updates

Vincent reminded Commissioners that Brandon Donahue began his residency on June 6, 2017 and will continue until July 6, 2017 for the new Madison Community Center. Neighborhood and Artist Development Coordinator Lauren Fitzgerald reported that THRIVE outreach is continuing and eight informational sessions are scheduled at various locations around the city.
