F. Other Discussion & Updates

a. Board Retreat Interviews

Chair Edmonds reminded board members to respond to email and set up pre retreat interviews with Deb Palmer George; she also informed the board that a follow up email would be sent out with the link available.

b. Public Art Updates

Public Art Project Manager Anne-Leslie Owens reported that a reception for the Art Works: MOB collection is tentatively scheduled for December 20 following the board meeting.

Public Art Project Manager Van Maravalli informed commission that there had been a meeting with MLS and interest in Public Art at the soccer stadium/fairgrounds site was expressed. She also informed the board that *Build Better Tables* catalogs were complete and had been distributed. It was also mentioned that Learning Lab was recognized as one the nation's best public art projects in 2017 through the Americans for Arts Public Art Network Year in Review.

c. Operational Updates

Finance and Operations Director Ian Myers stated there weren't any major operational updates. There was a question posed about budget adjustments to align with the savings plan and Myers informed Commission that Metro Arts was on target for savings.

G. New Business

Board members revisited the vacation time increase allotted to new Executive Director, Caroline Vincent. It was decided to increase the 15 days of vacation days by 3 for a total of 18 vacation days.
