Ms. McDaniel then opened the organizational meeting for discussion about the committee and what its charge should be.



The Nashville Minority Business Center (Center) is the leading, oldest, and continuously operating minority economic development institution in Middle Tennessee. With the leverage of public and private sector resources, the Center has been instrumental in helping to create economic **independence** for minorities for the past 25 years.

Eight primary program elements of the Center include; Minority Enterprise Development Week Business Development Conference, The One **Fund** - low Interest Revolving Loan Fund, Advocacy Initiatives, **Contractors** Plan Room, Education and Training, Management and Technical Assistance, Community Outreach and Marketing. 

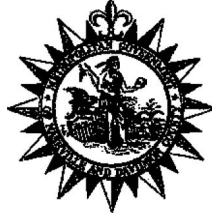

Dear Chairman Dickens and Members:

Now that council has approved the financing for the Convention Center project, we must turn our attention to the actual **construction** of the Music City Center. In addition, we must satisfy the commitments that were made during **our deliberations**. One such commitment I am interested in **following-up** on is my conversation with Finance Director Richard Riebeling on January 11, 2010. We had a chance to speak to the issue of providing sufficient **staff** to ensure compliance with the DBE program initiative. I asked Mr. Riebeling if there were sufficient funds for **staff** and resources set aside to achieve our goal of compliance and recruitment. My recollection is that he replied funds were set aside to allow for necessary resources for **staffing**.

I have conducted research on the expectations of the director of the program, and it is clear to me that we will need adequate staff to manage **all** aspects of the DBE recruiting, monitoring, and reporting required of a project of **this** magnitude. In order to effectively administer a DBE program for a \$585 million dollar project and have the DBE initiative present in **all** the individual bid packages to be let on this project will require that Ms. Bethune have some assistance. **This** is especially true to maintain the level of reporting required for the State of Tennessee, the Metropolitan Council and the Convention Center Authority.

I would like to know whether the Authority intends on hiring two to three staff persons to carry out the mission of the DBE program? In addition, should a separate budget **be** set aside for resources that are needed?

I would welcome the **opportunity** to appear before the Authority to discuss the matter further.

Re: Use of E-Verify System

Dear Chairman Dickens and Members:

Now that the Convention Center Authority is in the process of developing a policy for the procurement of contracts associated with the construction of the convention center, Members of Council have been receiving calls from constituents wanting to ensure that all workers on the project are legally eligible to work in this country. The U.S. Department of Homeland Security maintains an Internet-based system called "E-Verify" that allows employers to determine the eligibility of employees to work in the United States. The use of this system is free for employers, and there are currently more than 180,000 employers enrolled in the program.

We, as Members of the **Metropolitan** Council, are respectfully requesting that the procurement policy adopted by the Convention Center Authority include a requirement that all contractors and subcontractors use the E-Verify system to ensure their employees are eligible to work on the convention center project. This requirement could be built into each contract, which would cause the contractor to be in default if they failed to use the E-Verify system.

Thank you for your **service** and we appreciate you considering this request.

Re: Amendment to Convention Center Authority Charter

Dear Chairman Dickens and Members:

As you know, the Charter for the Convention Center Authority provides that the Board of Directors is to consist of nine members. At the time the members of the Board of Directors for the Convention Center Authority were confirmed by the Council in October 2008, a number of Members of Council commented that none of the nine members appointed by the Mayor have expertise in the construction, engineering, and architectural fields. While the nine members appointed are **certainly** well-qualified to operate and manage a new convention center, I continue to believe it is important, at least during the construction phase of the project, for the CCA Board of Directors to include persons **with** experience and expertise in the design and construction of large facilities.

The state enabling legislation for the Convention **Center** Authority sets forth a procedure for amending the Charter of the CCA. The Board of Directors must first submit an **application** to the Metropolitan Council seeking permission to amend the Charter and setting forth the proposed amendment to be made. The Council then must approve the amendment by resolution before it is submitted to the **Secretary** of State.

I am respectfully requesting that the CCA Board of Directors submit a proposed amendment for approval by the Council adding the following three positions as non-voting members of the Board to serve during the construction phase of the project: a structural engineer, an architect with experience in the design of large **commercial** facilities, a person with expertise in the construction industry. I believe this change will benefit the existing board, and will help protect the project from unnecessary cost overruns.

Thank you for **your** attention to this matter, and I look forward to hearing from you.
