With no additional business a motion was made to adjourn, with no objection the Marketing & Operations committee of the CCA adjourned at 10:06 a.m.



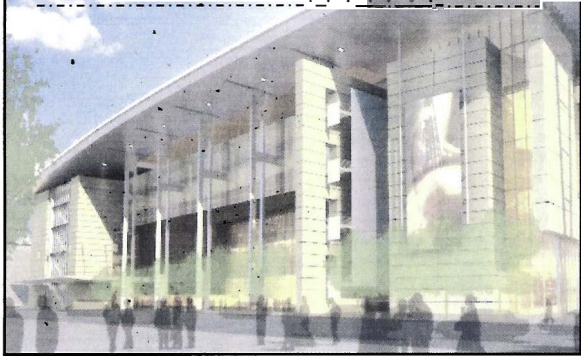

## Music City Center Construction Update

Greetings Downtown Neighbors!

Work on the Music City Center has officially begun. Barriers and fencing have been placed around the perimeter of the entire site to ensure public safety during construction. On February 8 the abatement and demolition phase began. The underground utility work in Demonbreun has begun. To see a video of the first demolition, visit the [MCC Facebook page](#).

This week, we will transition to our **street closure plan** for the duration of the project. The first street to be closed is Shirley / Franklin Street between Fifth and 8th Avenues. The closing of the following streets will be phased in this week, and it is expected that the entire site will be secure by the beginning of the week of February 22.

- Sixth Avenue South from Demonbreun to Shirley/Franklin Street
- Seventh Avenue South from Demonbreun to Shirley/Franklin Street
- Clark Place at 8th Avenue South
- Shirley/Franklin Street: portions will be open to local traffic only. No through traffic.
- Eastbound turning lane on Demonbreun between Fifth and Sixth Avenues

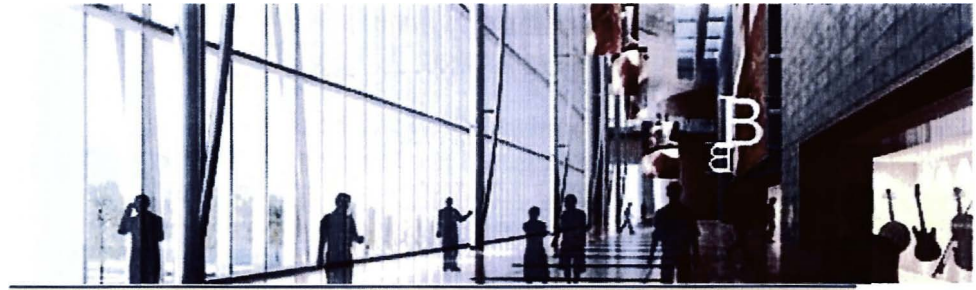

## Construction & Parking

### Overview

Construction activities for Music City Center have begun! The 16-acre site for Music City Center is bordered by Demonbreun on the north, Franklin / Shirley Street on the south, Fifth Avenue on the east, and Eighth Avenue on the west.

The site is comprised of 43 individual parcels, most of which have already been acquired by the Metropolitan Development & Housing Authority. Work on the site will begin in phases, starting with the parcels Metro already owns. The first phase of construction includes site preparation, abatement and demolition of existing structures.

### Project Status as of February 12, 2010

#### Construction & Parking

Barriers and fencing have been placed around the perimeter of the entire site to ensure public safety during construction. Abatement and demolition of existing buildings has begun.

Due to this activity, all public parking facilities within the boundaries of the Music City Center site are now permanently closed. Please visit the Downtown Partnership's [Park It! #### Street Closures

##### Intermittent street Closures

Currently, Portions of Demonbreun Street are closed for underground utility work between Sixth and Eighth avenues. During this time, Demonbreun Street is expected to remain open to two-way traffic. However, depending on the scope of the utility relocation and the result of the exploratory work that is being conducted, all lanes on Demonbreun between Seventh and Eight Avenues may have to close for some period of time. In that case, appropriate detours will be clearly marked. Check out our Twitter page for daily updates on exact lane closures.

##### Street Closure Plan for the Duration of Project Construction

It's anticipated that by the end of the week of February 15, all streets within the Music City Center site will be closed for the duration of construction.

Street closures will happen in the following order throughout the week with barriers and fencing put at each of these intersections:



- Clark Street at Eight Avenue South
- Shirley Street at Eight Avenue South
- Seventh Avenue South at Shirley Street
- Seventh Avenue South at Demonbreun
- Sixth Avenue South at Demonbreun
- Sixth Avenue South at Franklin

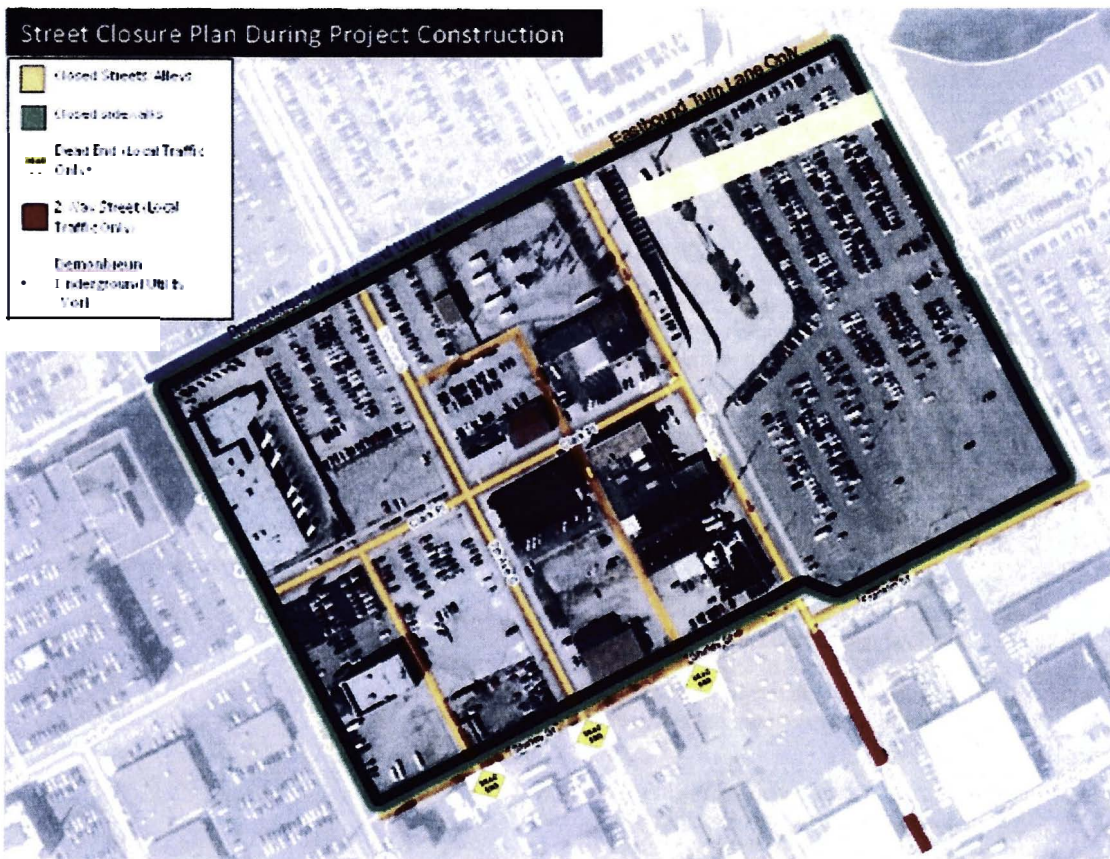
Once all of the intersections are blocked, the following streets will be closed for the duration of construction:

- Sixth Avenue South from Demonbreun to Shirley / Franklin Street
- Seventh Avenue South from Demonbreun to Shirley / Franklin Street
- Clark Place at Eighth Avenue South
- Shirley / Franklin Street: Portions will be open to local traffic only. No through traffic.
- Eastbound turning lane on Demonbreun between Fifth and Sixth avenues

As a result of the long-term street closures, all streets and alleys between Shirley / Franklin Street and Peabody Street will become dead end streets, accessible to local traffic only. Sixth Avenue South will become a two-way street between Shirley Shirley / Franklin Street and Peabody Street, also accessible to local traffic only.

All sidewalks on the perimeter of the site also will be closed.

Under the direction of Mayor Karl Dean and the Metro Council, on January 19, 2010, financing was approved for the new Music City Center (MCC). With financing now in place and construction set to begin in the coming weeks on the new, state-of-the-art Music City Center convention facility, there's never been a more exciting time to plan a meeting in Nashville.

The new, high-performance Music City Center, located adjacent to the Sommet Center on the south side of Broadway, will more than double the downtown meeting and exhibit space available in the current convention center.

Plans call for the facility to be built out at approximately 1.2 million square feet and feature a 350,000-square-foot exhibit hall acoustically designed to double as a concert hall, more than 50 meeting rooms, two ballrooms and approximately 36 loading docks for the ultimate in flexibility and ease.

The MCC will offer stunning views of the Nashville skyline and, in keeping with the city's commitment to sustainable development, boast a green roof. In addition, the building has been designed to capture Nashville's best attributes and immerse visitors in the unique character of Music City.

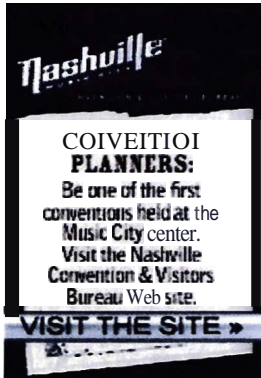
