SPEAKING TO THE COMMUNITY OVERSIGHT BOARD

For all Community Oversight Board meetings during the month of April, we encourage comments remotely.

Community Oversight Board meetings are held in accordance with the Board's Bylaws and Rules found on the Metro website.

GENERAL INFORMATION

The Community Oversight Board consists of eleven (11) members: seven (7) members are nominated by the community, two (2) members are nominated by Metro Council Representatives, and two (2) members are nominated by the Mayor. The Community Oversight Board meets holds its regularly scheduled meetings on the fourth Wednesday of the month at various locations throughout Nashville and Davidson County.

Pursuant to the Metro Charter, the Community Oversight Board has the Authority to investigate allegations of misconduct by the Metro Nashville Police Department (MNPD), offer and implement remedies to police accountability, and issue advisory and resolution reports to institutions involved in public safety and the administration of justice.

Agendas and staff reports are posted online prior to each meeting.

LEGAL NOTICE

As information to our audience, if you are not satisfied with a decision made by the Community Oversight Board, you may appeal the decision by petitioning for a writ of cert with the Davidson County Chancery Court or Circuit Court. Your appeal must be filed within sixty (60) days of the date of entry of the Community Oversight Board decision. To ensure that your appeal is filed in a timely manner and that all procedural requirements have been met, please be advised that you should contact independent legal counsel.
