Appellant appealed the 1) IBC 1029.1 Emergency escape and rescue. In addition to the means of egress required by this chapter, provisions shall be made for emergency escape and rescue openings in Group R-2 occupancies in accordance with Tables 1021.2(1) and 1021.2(2) and Group R-3 occupancies. Basements and sleeping rooms below the fourth story above grade plane shall have at least one exterior emergency escape and rescue opening in accordance with this section. 2) IBC 1107.6.2.2 Accessibility Group R-2 other than apartment houses monasteries and convents. The installation of one or more revolving doors in the building entrance shall not eliminate the requirement that a vestibule be provided on any doors adjacent to revolving doors. Exception #4 Doors that open directly from a place of less than 3000sf in area.
