Code Provision: The 2012 IPC Section 410.2: Minimum number. Where drinking fountains are required, not fewer than two drinking fountains shall be provided. One drinking fountain shall comply with the requirements for people who use a wheelchair and one drinking fountain shall comply with the requirements for standing persons.

Variance Requested: Appellant would like to appeal the IPC 2012 Section 410.2 requiring two drinking fountains by taking the exception that states that "a single drinking fountain that complies with the requirements for people who use a wheelchair and standing persons shall be permitted to be substituted for two separate drinking fountains". The unit we have installed is an accessible unit with a bottle fill tank above that accommodates standing persons. The owner will install a permanent cup dispenser on the side wall of the recess for their use.
