<u>Code Provision:</u> The 2012 IPC - Table 403.1 require A-3 occupancies with an occupant count of 247 persons to have 1 male water closet, 1 lavatory, 2 female water closets and 1 lavatory.

<u>Variance Requested:</u> Applicant proposes to have 1 male restroom with 1 water closet and 1 lavatory and 1 female restroom with 1 water closet and 1 lavatory.

Discussion: Rehab 4,504 sf for The Ballroom of Nashville.

The business is open for ballroom dancing classes, which are by appointment. Only a small group of people will be present in the building at any time.

The Board discussed possible issues in the future if this appeal were granted and also discussed how the space may be altered in order to reduce the occupant load.
