 - Each business had one dedicated historic commission person
 - o Historic Commission personnel issued permits quickly
 - o Created a task force to make recommendations to city on reconstruction
 - They hired a Historic Preservation consultant and they hired an engineer who specialized in bomb reconstruction
 - o Have issued 30 permits
 - Made 6% of the permits issued during that period
 - Partnerships have been strengthened and improved as a result of the tragedy

- Need plan for stabilization with administration
 - Asking for an ordinance so city can provide immediate stabilization in case of an emergency
 - For the purpose of Public Safety and Historic Preservation
 - Primarily for the downtown corridor of for buildings of significant historical value
- Be able to connect business owners or private citizens with an "insurance guru" so owners access all the money they are owed from an insurance policy
- Impressed with how Nashvillians came together
- CM Syracuse had been pushing for an incentive for historic building owners to preserve their buildings
- 7. Reports from the leadership of various committee/working groups
 - CM Martinez to upload all AAR's received to the shared drive
 - CM Oliver advises that they are done collecting documents and information and will be prepared to turn over their information to the Lessons Learned
 - CM Hollin asked about the AOC and whether they can present to the commission
