Chairperson Gene Ward called the meeting of October 8, 2012 to order at 3:00 p.m.

**CALL TO ORDER**

Chairperson Gene Ward mentioned Ordinance No. BL2006-1050 regarding the appeals process of the Traffic and Parking Commission.

*“If you are not satisfied with a decision made by the Traffic & Parking Commission, you may appeal the decision by filing for a writ of certiorari with the Davidson County Chancery or Circuit Court. Your appeal must be filed within 60 days of the date of the entry of the Commission’s decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.”*

**APPROVAL OF AGENDA**

Mr. Morin moved for **approval** of the Agenda, seconded by Rev. Mitchell and **approved with no opposition**.

**APPROVAL OF MINUTES**

Mr. Green amended the minutes for September and noted that we pulled the modification of speed limit on 31<sup>st</sup> Ave off of the Consent Agenda. Rev Mitchell motioned for approval of the minutes as amended for the meeting of August 12 and September 10, 2012, seconded by Rev. Mitchell.

**New Business**

1. **Proposal No. 2012M-015AB-001** – A request to abandon a portion of Alley No. 555 (easements and utilities to be abandoned and relocated) from Dr. D.B. Todd Jr. Blvd eastward approximately 120 feet between properties located at 1724, 1726 and 1728 Scovel Street and 1729 and 1733 Heiman Street, requested by Ragan – Smith Associates, applicant, Lee Chapel AME Church and Clinton Smith.

2. **Proposal No. 2012M-016AB-001** – A request to abandon an unnumbered alley (easements to be retained from Franklin Limestone Rd. southeastward to its terminus between properties located at 204 and 208 Franklin Limestone Road and 2101, 2107 A, 2115 and 2127 Murfreesboro Pike, requested by William P. Cooper III, abutting property owner.

**Approved by Hand Vote 7-1**

3. **Vanderbilt Shuttle Service** - permitting shuttle service in the Acklen Park / Orleans Av / Love Circle area

Mr. Knauf stated that this comes before Commission per code related to the permitting of specific vehicles. Metro Public Works and the Commission can grant a permit for vehicle travel in areas that are restricted from commercial vehicles. Furthermore, Vanderbilt would like to use a route on Acklen Ave and Orleans Ave for their transportation shuttle.

Ms. Mary Pat Teague states that they would like to use this route as it prevents from having unsafe turns at the drop off locations. She said on the previous route that they would have to back into the street causing major traffic issues.

Mr. Dan Barge stated to the Commission that his firm had studied this route and determined it to be the safest for the Vanderbilt Shuttle bus.

Mr. Green motioned for approval, seconded by Rev. Mitchell
