"If you are not satisfied with a decision made by the Traffic & Parking Commission, you may appeal the decision by filing for a writ of certiorari with the Davidson County Chancery or Circuit Court. Your appeal must be filed within 60 days of the date of the entry of the Commission's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met."

NEW BUSINESS – Consent Agenda

1. **Resolution 13-12:**
 - Authorize traffic signal on Tulip Grove Rd at Old Lebanon Dirt Rd
 - Authorize traffic signal on 17th Ave S and Horton Ave

- Authorize all way stop on Orlando Rd at Patina Circle
 - Authorize all way stop on Barclay Dr at Brittany Dr
 - Authorize all way stop on Freda Villa at Saunders Ave
2. *Embry Development
- Convert 4th Ave N from one way to two way from Jefferson St to Jackson St
 - Authorize 60' loading zone on the west side of 4th Ave N south of Jefferson St
 - Authorize 220' of unmetered parking on the west side of 4th Ave N south of Jefferson St
- *Effective at earlier of Embry occupancy or closing of 4th Ave N, south of Jackson St.
- *Property owner shall, for forty eight months following adoption, receive a minimum of five day's notice prior to the Commission considering changes.

Mr. Morin made a motion to **approve** the consent agenda, seconded by Mr. Green and **approved with no opposition.**

Traffic and Parking Commission Resolution No. 13-11 authorized by Chapter 9 of the Charter of the Metropolitan Government of Nashville and Davidson County, Tennessee as amended

BE IT RESOLVED by the Traffic and Parking Commission of the Metropolitan Government of Nashville and Davidson County, Tennessee as follows:

SECTION I: That Chapter 12 of said Metropolitan Code, said Chapter being entitled 'Vehicles and Traffic' is amended as follows:

SECTION II. BE IT FURTHER RESOLVED that this Resolution be published in a daily newspaper in Metropolitan Nashville/Davidson County, Tennessee, and that a certified copy be filed with the Chief of Police of the Metropolitan Police Department, and that a certified copy be filed with the Metropolitan clerk, and that said Resolution take effect five (5) days thereafter.
