Chairman Feller Brown called the meeting of June 9, 2014 to order at 3:00 p.m.

CALL TO ORDER

Chairman Brown mentioned Ordinance No. BL2006-1050 regarding the appeals process of the Traffic and Parking Commission.

“If you are not satisfied with a decision made by the Traffic & Parking Commission, you may appeal the decision by filing for a writ of certiorari with the Davidson County Chancery or Circuit Court. Your appeal must be filed within 60 days of the date of the entry of the Commission’s decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.”

Consent Agenda

Proposal No. 2014M – 006AB – 001 – A request to abandon Alley #241 (easements to be retained) from 12th Ave North westward to its intersection with Keys Alley and to abandon Keys Alley (easements to be retained) from its intersection with Alley #241 northward to its terminus. Requested by North Gulch Partners II, LLC.
2. Proposal No. 2014M – 007AB – 001 – A request to abandon Alley #233 (easements and utilities to be abandoned and relocated) from 12th Ave S westward to its terminus at Interstate 40, requested by Civil Site Design Group, PLLC, applicant.
3. Proposal No. 2014M – 008AB – 001 – A request to abandon a portion of Alley #1999 (easements and utilities to be retained) adjacent to the northern property line of Tax Map Parcel # 08303026000, Requested by OGA, applicant, Kelley Properties, LLC, owner.

BE IT FURTHER RESOLVED that this Resolution be published in a daily newspaper in Metropolitan Nashville/Davidson County, Tennessee, and that a certified copy be filed with the Chief of Police of the Metropolitan Police Department, and that a certified copy be filed with the Metropolitan clerk, and that said Resolution take effect five (5) days thereafter.
