

Traffic and Parking Commission Resolution No. 14-09 authorized by Chapter 9 of the Charter of the Metropolitan Government of Nashville and Davidson County, Tennessee as amended

BE IT RESOLVED by the Traffic and Parking Commission of the Metropolitan Government of Nashville and Davidson County, Tennessee as follows:

SECTION I: That Chapter 12 of said Metropolitan Code, said Chapter being entitled 'Vehicles and Traffic' is amended as follows:

1. Schedule I, 'Traffic Control Signals'

DELETE:

46th Av N and Murphy Rd

ADD:

46TH AVE N and MURPHY RD

3. Schedule III, 'Turn Prohibitions'

Section A: No Left, Right, or U Turn

DELETE:

Charlotte Av-Easterly to 10th Cr N-Northerly 6am To 9am & 3pm To 6pm

ADD:

DAVIDSON RD to H G HILL MIDDLE SCHOOL

6. Schedule VI, 'Stop and Yield Intersections'

ADD:

AUTHORIZE STOP on BONNER AVE at EDEN AVE

STOP on NEELYS CHASE DR at ROTHWOOD AVE

7. Schedule VII, 'Parking Restrictions'

Section A: Stopping, Standing, or Parking Prohibited

ADD:

CLEARVIEW, both sides from S 11TH ST to 100' S OF S 11TH ST, 2 HOUR

PARKING

SHURGUARD WAY, west side from SHURGUARD WAY to SHURGUARD WAY, NO PARKING

Section C: Curb Parking

ADD:

4TH AVE S, east side from NORTH OF PEABODY to PEABODY, TAXI STAND ON THE EAST SIDE OF 4TH AVE

5TH AVE N, south side from 5TH AVE NORTH to 5TH AVE NORTH, VALET FOR THE
SILO 10 AM - PM SUN & 5PM - 12 24/7

5TH AVE S, south side from 104 5TH AVE S to 106 5TH AVE S, PUB 5 11 AM -
2 PM 7 DAYS A WEEK

7TH AVE N, north side from 7TH AVE N to 7TH AVE N, TOUR - TAXI PARKING

12TH AVE S, north side from 12TH AVE S to 12TH AVE S, 404 KITCHEN 24/7

20TH AVE N, east side from SOUTH STREET to SOUTH STREET, VALET ZONE

VILLA PLACE, west side from EDGHILL to VILLA PL, VALET 11AM - 2 PM 7 DAYS
A WEEK


8. Schedule VIII, 'Parking Meters'

Section I-1: 1.00/1 Hour, Limit 2 Hours


ADD:

GLEAVES ST, both sides from OVERTON AVE to 9TH AVE S




