

Traffic and Parking Commission Resolution No. 14-10 authorized by Chapter 9 of the Charter of the Metropolitan Government of Nashville and Davidson County, Tennessee as amended

BE IT RESOLVED by the Traffic and Parking Commission of the Metropolitan Government of Nashville and Davidson County, Tennessee as follows:

SECTION I: That Chapter 12 of said Metropolitan Code, said Chapter being entitled 'Vehicles and Traffic' is amended as follows:

4. Schedule IV, 'One Way Streets and Alleys'

ADD:

9th AVE S southbound from EDGEHILL to OLYMPIC ST

6. Schedule VI, 'Stop and Yield Intersections'

ADD:

STOP on ARGYLE AVE at DUE WEST AVE

STOP on ROME AVENUE at HITE STREET

ALL WAY STOP on S 17th STREET at SHELBY

ALL WAY STOP on STROMBURY DRIVE at WILLESDEN COURT

7. Schedule VII, 'Parking Restrictions'

Section C: Curb Parking

DELETE:

11th Ave N, east side from 314 11th Ave S to Pine St, Valet Stand

ADD:

11TH AVE S, east side from 12TH AVE S to 115' NORTH OF 12TH AVE S, VALET STAND

11TH AVE S, east side from 314 11TH AVE S to 314 11TH AVE S, VALET PARKING 5PM - 3AM

12TH AVE N, west side from GRUNDY STREET to PORTER STREET, VALET STAND 11 AM - 3 AM 7 DAYS A WEEK

BEDFORD AVE, both sides from CRESTMOOR to ABBOTT MARTIN, 2 HOUR PARKING MAIN STREET, east side from 507 MAIN STREET to 507 MAIN STREET, VALET STAND 11AM - 12 AM 7 DAYS A WEEK

8. Schedule VIII, 'Parking Meters'

Section I-1: 1.00/1 Hour, Limit 2 Hours

ADD:

HARRISON ST, south side from 3RD AVE N to CRIDDLE ST

9. Schedule IX, 'Limitations on Size of Vehicles'

Section D: Prohibit Vehicles in excess of 16000 pounds

ADD:

CLAY STREET from DB TODD BLVD to DELTA AVE

10. Schedule X, 'Loading Zones'

Section A: Commercial

DELETE:

SHELBY AVE, south side (816 SHELBY AVE), 60', LOADING ZONE SATURDAY AND SUNDAY 10AM - 6PM ONLY (RIVER CHURCH)

ADD:

3rd AVE S, south side (103 3RD AVE S), 100', LOADING ZONE 5:30 AM - 7:30 AM (103 3RD AVE S)

BEDFORD AVE, south side (3800 BEDFORD AVE),', LOADING ZONE (COURTYARD MARRIOTT)

SECTION II. BE IT FURTHER RESOLVED that this Resolution be published in a daily newspaper in Metropolitan Nashville/Davidson County, Tennessee and that a certified copy be filed with the Chief of Police of the Metropolitan Police Department, and that a certified copy be filed with the Metropolitan clerk, and that said Resolution take effect five <5> days thereafter.
