Your appeal must be filed within 60 days of the date of the entry of the Commission’s decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.”

4. Authorize valet stand at 1929 Broadway for Union Common; 5pm – 2 am 7 days a week – deferred from September 2014

Consent Agenda

1. **Proposal No. 2014M – 012AB – 001** – A request to abandon a portion of Alley # 115 and all of Alley # 123 (easements and utilities to be abandoned and relocated) between Clark Place and Lea Avenue, requested by Civil Site Design Group, applicant: Nashville Hospitality Capital. LLC, adjacent property owner.
2. **Resolution 10-14:**
 - Modify the southbound lane of 9th Ave S from two way to one way from 7:15 to 8:15 AM and 2:30-3:30 PM Monday thru Friday only.
 - Authorize all way stop on Strombury Drive at Willesden Court
 - Authorize all way stop on S 17th Street at Shelby Ave
 - Authorize all way stop on Argyle Ave at Due West Ave
 - Authorize stop sign on Rome Avenue at Hite Street
 - Authorize “No trucks over 8 tons” on Clay Street from DB Todd Blvd to Delta Ave
 - Authorize Loading Zone at 150 3rd Avenue S from 5AM to 7:30 AM
 - Authorize Loading Zone at 3800 Bedford Ave
 - Authorize parking meters on Harrison Street between 3rd Avenue N and Criddle Street

- Authorize 2 hour parking on both sides of Bedford Avenue from Crestmoor to Abbott Martin
- Modify Valet Stand at 314 11th Ave S (Bar Louie) from 5PM – 3 AM
- Authorize valet stand on the west side of 12th Avenue N between Grundy Street and Porter Street from 11 AM – 3 AM, 7 days a week
- Authorize valet stand at 507 Main Street from 11AM – 12AM for the Field House, 7 days a week
- Authorize loading zone on 11th Ave S from 12th Ave S to 115' N of 12th Ave S. (Note: 50' of proposed valet zone is contingent on developer arranging relocation of B – Cycle)
