Chairman Feller Brown called the meeting of March 09, 2015 to order at 3:00 p.m.

CALL TO ORDER

Chairman Brown mentioned Ordinance No. BL2006-1050 regarding the appeals process of the Traffic and Parking Commission.

"If you are not satisfied with a decision made by the Traffic & Parking Commission, you may appeal the decision by filing for a writ of certiorari with the Davidson County Chancery or Circuit Court. Your appeal must be filed within 60 days of the date of the entry of the Commission's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met."

3. **Proposal No. 2015M – 006AB – 001** – A request to abandon a portion of Franklin Pike Circle right – of – way (easements and utilities to be abandoned) on properties located at 5644 and 5648 Franklin Pike Circle from the northwest corner of parcel 187 to the southwest corner of parcel 060, requested by Dale & Associates, applicant; Land Development. Com, Inc. Owner

- Authorize taxi stand on the west side of 3rd Ave N, 200' in length
- Authorize loading zone on the west side of 3rd Ave N, 200 in length

Mr. Turner made a motion to remove the no left turn on Davidson from 8:30-9:30 am and 3:30-4:30 pm from the consent agenda and **defer one month**, seconded by Ms. Mary Vavra and **approved with no opposition**.

Mr. Green made a motion to approve the revised consent agenda, seconded by Mr. Turner and **approved with no opposition**.

Appeals

1. Request to appeal the denial of proposed installation of no parking signs on Aquatic Rd. from Northcrest Dr. to Millerwood Dr. Appeal requested by April Wortham.

Mr. Green made a motion to **deny the appeal**, seconded by Mr. Turner and **approved by a 7-0 Vote**.

2. Appeal the denial of a traffic signal on Lisa Lane at Lebanon Rd. Requested by Ms. Gloria Agularia.

Mr. Turner made a motion to **deny the appeal**, seconded by Mr. Green and **approved by a 7-0 Vote**.

Old Business

1. Modify residential permit parking on 15th Ave S at Roundabout and Wedgewood – deferred from January 2015

Mr. Green made a motion to **indefinitely defer**, seconded by Mr. Turner and **approved by a 7-0 Vote**.

2. Authorize the modification of speed limit from 35 mph to 30 mph on Jocelyn Hollow from Davidson Dr. to dead end.

Councilman Harrison made a motion to **indefinitely defer**, seconded by Mr. Green and **approved by a 7-0 Vote**.

3. Authorize no parking on both sides of Hampton St. from W Trinity Lane to Avondale Circle
4. Authorize no parking on both sides of Avondale Circle from Brick Church Pk to Hampton St
5. Authorize no parking on the south side of Avondale Cr from Hampton St to 450' west of Hampton St

Councilman Harrison made a request to **indefinitely defer** old business item numbers 1, 2, and 3, seconded by Mr. Green and **approved by a 7-0 Vote**.

BE IT RESOLVED by the Traffic and Parking Commission of the Metropolitan Government of Nashville and Davidson County, Tennessee as follows:

SECTION I: That Chapter 12 of said Metropolitan Code, said Chapter being entitled 'Vehicles and Traffic' is amended as follows:

SECTION II. BE IT FURTHER RESOLVED that this Resolution be published in a daily newspaper in Metropolitan Nashville/Davidson County, Tennessee, and that a certified copy be filed with the Chief of Police of the Metropolitan Police Department, and that a certified copy be filed with the Metropolitan clerk, and that said Resolution take effect five (5) days thereafter.
