

Traffic and Parking Commission Resolution No. 15-04 authorized by Chapter 9 of the Charter of the Metropolitan Government of Nashville and Davidson County, Tennessee as amended

BE IT RESOLVED by the Traffic and Parking Commission of the Metropolitan Government of Nashville and Davidson County, Tennessee as follows:

SECTION I: That Chapter 12 of said Metropolitan Code, said Chapter being entitled 'Vehicles and Traffic' is amended as follows:

1. Schedule I, 'Traffic Control Signals'

ADD:

OLD HICKORY BLVD and HERMITAGE PARK DR

6. Schedule VI, 'Stop and Yield Intersections'

ADD:

ALL WAY STOP on S 11TH ST at FORREST AVE

7. Schedule VII, 'Parking Restrictions'

Section A: Stopping, Standing, or Parking Prohibited

DELETE:

BANK ST ALLEY, both sides from 2ND AVE N to 3RD AVE N, PARKING FOR METRO EMPLOYEES ONLY

Section C: Curb Parking

ADD:

2nd AVE N, west side from NORTH OF BANK ST ALLEY to NORTH OF BANK ST ALLEY, VALET STAND

3RD AVE N, east side from HARRISON ST to 300' N OF HARRISON ST, RESIDENTIAL PERMIT PARKING

4TH AVE N, east side from HARRISON ST to 225' SOUTH OF HARRISON ST, RESIDENTIAL PERMIT PARKING

HARRISON ST, north side from 3RD AVE N to 270' WEST OF 3RD AVE N, RESIDENTIAL PERMIT PARKING

8. Schedule VIII, 'Parking Meters'

Section R: Parking Meters

DELETE:

2 Parking meters on the east side of 112 2nd AVE N

2 Parking meters on the west side of 2nd AVE N, north of BANK ST ALLEY

Parking meters on both sides of 4th AVE N from 3rd AVE N to west of 3rd AVE N

10. Schedule X, 'Loading Zones'

Section A: Commercial

DELETE:


6th Av N, (1325), 50', 7am-5pm (Coronado Products Inc)


ADD:


2nd AVE N, east side (112 2ND AVE N), 50', M-TH 11AM-9PM FR-SAT 9AM-11PM
(DOC HOLIDAYS)


BROADWAY, south side (101 BROADWAY), 50', 24 HOUR LOADING ZONE (ACME FEED
& SEED)


SECTION II. BE IT FURTHER RESOLVED that this Resolution be published in a daily newspaper in Metropolitan Nashville/Davidson County, Tennessee and that a certified copy be filed with the Chief of Police of the Metropolitan Police Department, and that a certified copy be filed with the Metropolitan clerk, and that said Resolution take effect five <5> days thereafter.


