Chairman Feller Brown called the meeting of June 08, 2015 to order at 3:00 p.m.

CALL TO ORDER

Chairman Brown mentioned Ordinance No. BL2006-1050 regarding the appeals process of the Traffic and Parking Commission.

"If you are not satisfied with a decision made by the Traffic & Parking Commission, you may appeal the decision by filing for a writ of certiorari with the Davidson County Chancery or Circuit Court. Your appeal must be filed within 60 days of the date of the entry of the Commission's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met."

Proposal No. 2015M-012AB-001** – A request to abandon right – of – way from Blakemore Ave to Alley # 647 and a portion of Blakemore Ave from Alley # 922 eastward (easements and utilities to be abandoned) on properties located at 1610 21st Ave S and 2024 Blakemore Ave, requested by Littlejohn Engineering, applicant; First American Bank of Nashville, Owner.

- Authorize truck restriction on 9th Ave N from Jefferson St to Tredco Dr
- Authorize truck restriction on Locklayer St from Rosa L Parks to 10th Ave N
- Authorize "no parking anytime" on the south side of Hickory Street from S Gallatin Pk to Brawner Ave
- Remove all parking meters on the east side of 6th Ave N from Union to Deaderick and 7th Ave N from Union to Charlotte Ave and install signs for "Trooper Parking Only"
- Authorize Taxi Cab stand on the north side of Korean Veteran Blvd at 3rd Ave S
- Remove Taxi Cab stand on 4th Ave S from 3rd Ave S to Almond St
- Remove Loading Zone at 410 4th Ave S from Peabody to Korean Vets Blvd (The Rutledge)

The following item was removed from the consent agenda to discuss.

Authorize all way stop on S 14th St and Shelby Ave

Council Member Westerholm stated that he is in favor of the all way stop on S 14th and Shelby Ave. He stated that he would like to see some overhead notification of the stop sign.

Council Member Harrison made a motion to **approve**, seconded by Ms. Vavra and **approved with no opposition.**

Old Business

1. Authorize "no parking anytime" on both sides of Estes Rd from Woodmont Circle to Crescent Rd.

Ms. Vavra made a motion to approve, seconded by Council Member Harrison and **approved with no opposition.**

New Business

1. Request to provide complimentary parking in the Metro Courthouse Garage for the 2015 Music City 4th of July Concert.
 - 50 spaces for Tuesday, June 30, 2015. 7am arrival and departure in evening.
 - 50 spaces for Wednesday, July 1, 2015. 7am arrival and departure in evening.
 - 50 spaces for Thursday, July 2, 2015. 7am arrival and departure in evening.
 - 100 spaces for Friday, July 3, 2015. 7am arrival and departure in the evening.

- 250 spaces for Saturday, July 4, 2015. A few may park early in the day but the majority will arrive in the 5pm – 7pm timeframe. I would expect the majority to exit the garage in the 10:30pm – 11:30pm timeframe following the conclusion of the event with the remainder departing 2:00am.
- 50 spaces for Sunday, July 5, 2015. 7am arrival and departure in the evening.

Ms. Vavra made a motion to approve, seconded by Council Member Harrison and **approved with no opposition.**

2. Cars 2 go

Council Lady Allen and presented the Council Bill to the Commission on the Cars 2 go program.

SECTION I: That Chapter 12 of said Metropolitan Code, said Chapter being entitled 'Vehicles and Traffic' is amended as follows:

BE IT FURTHER RESOLVED that this Resolution be published in a daily newspaper in Metropolitan Nashville/Davidson County, Tennessee, and that a certified copy be filed with the Chief of Police of the Metropolitan Police Department, and that a certified copy be filed with the Metropolitan clerk, and that said Resolution take effect five (5) days thereafter.
