

Traffic and Parking Commission Resolution No. 15-07 authorized by Chapter 9 of the Charter of the Metropolitan Government of Nashville and Davidson County, Tennessee as amended

BE IT RESOLVED by the Traffic and Parking Commission of the Metropolitan Government of Nashville and Davidson County, Tennessee as follows:

SECTION I: That Chapter 12 of said Metropolitan Code, said Chapter being entitled 'Vehicles and Traffic' is amended as follows:

2. Schedule II, 'Speed Limits'

DELETE:

OLD HICKORY BLVD from BELL RD TO BURKITT RD, 35mph

ADD:

JOCELYN HOLLOW RD from DAVIDSON DR to DEAD END, 30mph

OLD HICKORY BLVD from BELL RD to BURKITT RD, 40mph

6. Schedule VI, 'Stop and Yield Intersections'

ADD:

AUTHORIZE STOP on 4TH AVE N at JOE GILLIAM WAY

AUTHORIZE STOP on ASHLAWN CIRCLE at ASHLAWN DRIVE

AUTHORIZE STOP on ASHLAWN COURT at ASHLAWN DRIVE

AUTHORIZE STOP on BAKERS GROVE LANE at BAKERS GROVE RD

AUTHORIZE STOP on PALMER AVE at PIERCE RD

AUTHORIZE STOP on REVELS DR at ROWAN DR

7. Schedule VII, 'Parking Restrictions'

Section C: Curb Parking

DELETE:

9TH AVE S, north side from 609 9TH AVE S to 611 9TH AVE S, VALET PARKING STAND

11TH AVE S, east side from 314 11TH AVE S to 314 11TH AVE S, VALET PARKING 5PM - 3AM

12th AVE S, south side from 12TH AVE S to 12TH AVE S, VALET STAND 3P-12A M-F 9A- 12A S-S

12TH AVE S, north side from 12TH AVE S to 12TH AVE S, 24/7

BELCOURT AV, south side from ALLEY E of 21st AV S to ALLEY E of 20th AV S, Valet Parking 11am-2pm, 5pm-mid

CHURCH ST, west side from 1703 CHURCH ST to 1705 CHURCH ST, VALET PARKING STAND

167 ROSA PARKS BLVD, north side, The Standard Rest, Valet Stand 6p-12a
