

Traffic and Parking Commission Resolution No. 15-11 authorized by Chapter 9 of the Charter of the Metropolitan Government of Nashville and Davidson County, Tennessee as amended

BE IT RESOLVED by the Traffic and Parking Commission of the Metropolitan Government of Nashville and Davidson County, Tennessee as follows:

SECTION I: That Chapter 12 of said Metropolitan Code, said Chapter being entitled 'Vehicles and Traffic' is amended as follows:

1. Schedule I, 'Traffic Control Signals'

ADD:

- ASHEFORD TRACE and MT. VIEW RD

3. Schedule III, 'Turn Prohibitions'

Section B: No Turn on Red

DELETE:

- 21st AVE S to WEDGEWOOD AVE

6. Schedule VI, 'Stop and Yield Intersections'

ADD:

- ALL WAY STOP on BRANTLEY DR at LERA JONES DR

7. Schedule VII, 'Parking Restrictions'

Section A: Stopping, Standing, or Parking Prohibited

ADD:

- 1ST AVE S, east side from MOLLOY ST to DEMONBREUN, 30 MINUTE PARKING
MIDDLETON, north side from 7th AVE S to EWING AVE, 2 HOUR PARKING BETWEEN
8AM-6PM

Section C: Curb Parking

ADD:

- 12TH AVE S, south side from 601 12th AVE S to 601 12th AVE S, VALET STAND
11A-2P/5P-12A 7 DAYS A WEEK
- 12th AVE S, east side from 592 12th AVE S to 592 12th AVE S, VALET STAND
- 11A-2P/5P-12A 7 DAYS A WEEK
- 15TH AVE S, both sides from TREEMONT AVE to GRAND AVE, 2 HOUR RESIDENTIAL
PERMIT PARKING

- HOUSTON ST, north side from 434 HOUSTON ST to 434 HOUSTON ST, VALET STAND
24 HOURS 7 DAYS A WEEK

9. Schedule IX, 'Limitations on Size of Vehicles'

Section D: Prohibit Vehicles in excess of 16000 pounds

ADD:

- BROOKVIEW ESTATES from BENZING RD to OCALA DR.

10. Schedule X, 'Loading Zones'

Section A: Commercial

ADD:

- HAYES ST, (1802 HAYES ST), 75', LOADING ZONE 7A-5P M-F (1802 HAYES ST)

SECTION II. BE IT FURTHER RESOLVED that this Resolution be published in a daily newspaper in Metropolitan Nashville/Davidson County, Tennessee and that a certified copy be filed with the Chief of Police of the Metropolitan Police Department, and that a certified copy be filed with the Metropolitan clerk, and that said Resolution take effect five <5> days thereafter.
