

Traffic and Parking Commission Resolution No. 16-11 authorized by Chapter 9 of the Charter of the Metropolitan Government of Nashville and Davidson County, Tennessee as amended

BE IT RESOLVED by the Traffic and Parking Commission of the Metropolitan Government of Nashville and Davidson County, Tennessee as follows:

SECTION I: That Chapter 12 of said Metropolitan Code, said Chapter being entitled 'Vehicles and Traffic' is amended as follows:

6. Schedule VI, 'Stop and Yield Intersections'

ADD:

STOP on BRENNER DR at BAY COVE TRAIL

STOP on DIANE CT at DIANE DR

ALL WAY STOP on WINGATE AVE at MORTON AVE

ALL WAY STOP on ABERDEEN RD at MOCKINGBIRD RD

7. Schedule VII, 'Parking Restrictions'

Section A: Stopping, Standing, or Parking Prohibited

ADD:

INTERSTATE DR, both sides from SHELBY ST to RUSSELL ST, NO VENDING ANYTIME

Section B: Angle Parking

ADD:

BLAKEMORE AVE, both sides from 32ND AVE S to NATCHEZ TRACE, MON - FRI 8A-4P RESIDENTIAL PERMIT PARKING 2 HOUR PARKING FOR NON PERMIT HOLDERS.

TAYLOR ST, south side from 3RD AVE N to 4TH AVE N, RESIDENTIAL PERMIT PARKING

Section C: Curb Parking

ADD:

11th AVE N, north side from PINE ST to 12th AVE N, VALET STAND 5 SPACES

12TH AVE S, west side from 30' SOUTH OF 12th AVE S to DEMONBREUN, VALET STAND DEL FRISCO'S

9. Schedule IX, 'Limitations on Size of Vehicles'

Section D: Prohibit Vehicles in excess of 16000 pounds

ADD:

BELLEVUE RD from OLD HARDING PK to OLD HICKORY BLVD

OLD NEWSOME STATION RD from McCRORY LANE to DEAD END

10. Schedule X, 'Loading Zones'



Section A: Commercial



ADD:

DEMONBREUN ST, west side (1201 DEMONBREUN ST), 50', 50 FOOT 24 HOUR LOADING ZONE (ENCORE)

MAIN ST, south side (NEIL AVE), 50', LOADING ZONE (HOLIDAY JONES DEVELOPMENT)

SECTION II. BE IT FURTHER RESOLVED that this Resolution be published in a daily newspaper in Metropolitan Nashville/Davidson County, Tennessee and that a certified copy be filed with the Chief of Police of the Metropolitan Police Department, and that a certified copy be filed with the Metropolitan clerk, and that said Resolution take effect five <5> days thereafter.
