CALL TO ORDER

Chairman John Green mentioned ordinance No. BL2006-1050 regarding the appeals process of the Traffic and Parking Commission.

"If you are not satisfied with a decision made by the Traffic & Parking Commission, you may appeal the decision by filing for a writ of certiorari with the Davidson County Chancery or Circuit Court. Your appeal must be filed within 60 days of the date of the entry of the Commission's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met."

- i) **CD16:** Authorize stop sign on Mavert Dr. at Lake Park Dr.; requested by resident
- j) **CD19:** Authorize traffic signal at 6th Ave. N. and Jefferson St.; requested by resident
- k) **CD19:** Authorize all- way stop at 403 Van Buren St.; requested by resident
- l) **CD19:** Authorize conversion of one vehicle parking space into a bike/scooter corral at 114 2nd Ave. S.; requested by Metro Public Works
- m) **CD20:** Authorize all-way stop at 49th Ave. and Illinois Ave.; requested by CM Roberts

OTHER BUSINESS

1. CD19: Authorize no parking or standing on south side of Green St. from 155 Green St. to the interstate ramp; requested by Metro Public Works

Police of the Metropolitan Police Department, and that a certified copy be filed with the Metropolitan clerk,
and that said Resolution take effect five (5) days thereafter.
