BOARD DENIES REQUEST FOR SUSPENSION OF RULES TO RENAME PUBLIC SQUARE PARK TO "DIANE NASH PARK"

As per recommendation of the Naming Committee, upon motion of Mr. Haynes and seconded by Mr. Anderson, the Board denied the request to defer the suspension of the rules to allow Public Square Park to be renamed "*Diane Nash Park*." Ms. Tari Hughes voted to oppose.

Mr. Jeff Haynes wanted to clarify the decision of the Naming Committee to deny the suspension of rules to rename Public Square Park to "Diane Nash Park." The committee agrees that she needs to be recognized. The decision had nothing to do with her name, it had more to do with the established subcommittee and rules for renaming that were put in place a year ago.

Request for conditional approval to accept a donation from Habitat for Humanity, of 2 tracts of land totaling 1.47-acres and proposed park improvements to the land. Tract One is a 1.14-acre portion of Parcel ID# 06000005700 located at 3017 Aldrich Lane. Tract Two is a 0.33-acre portion of Parcel ID# 06000008900 located at 520 Brick Church Park Drive. Conditions include:

- Parks staff-level approval of all design, construction and compliance with all Metro Parks standards and policies

BOARD DEFERS REQUEST TO AMEND LEASE FOR PROPERTY AT 7820 COLEY DAVIS TO ACQUISITION COMMITTEE

A lease amendment is requested for the property located at 7820 Coley Davis, Parcel ID# 14100007400 that Metro leases (and subleases) from the State of Tennessee Department of Transportation. The current lease with TDOT expires on December 31, 2037. Metro has a need for a new mobile emissions testing site in the Bellevue area and requests the Park Board's approval of an amendment to the lease with TDOT to allow the site to be utilized for this purpose.
