- Public Comments Jess Skim of B&C verbally appeals for the removal of roughly \$600 in late fees to be credited to his account. Angela asks that he makes this appeal in writing to her and Charles.
- Approval of January 26, 2022 Regular Meeting Minutes Brenda; move. Alex; second. Pass.
- Financial Overview Maria Marton presents financials through 1/22. 2022 Budget has been submitted to Metro, Mayor's Office review to take place March 11, 2022. Regarding increased Metro Water bills; no discovery was made with meter function. NFM to self-fund an investigation with contracted plumber to identifying any leaks. Once completed, Metro Water will adjust 2 months of service.
- Executive Director's Report Charles Kizer gives updates on progress of GLK kitchen damaged in fire in 2020. Ceiling framing is complete and external roofing work to commence in coming week.
- Appeals The Board hears appeal by Jack MacDowell of Moosehead Kettle Corn. Jack is appealing NFM staff decision to
  reject his 2022 Farm Shed application due to poor standing resulting form multiple rule violations. The violations refer to
  2021 NFM Merchant Guidelines and Policies, Rules of Conduct; repeat parking violations and hostility towards staff. Each
  side is given approximately 10 minutes to make their case verbally and with backing documentation, shared with both
  vendor, NFM staff and Board members. After hearing each side, Board members are given opportunity to ask clarifying
  questions to both parties. Jack provides his side of the story including photos of parked cars inside the farm shed of the
  market and accounts of discrimination by NFM staff. NFM staff provides their documentation of the incident including
  weekend recaps created by Heather Hoch, email correspondence between staff and Moosehead owners, NFM policies and
  NFM Board policies, and an incident report created by Metro contractor Archangel Protective Services. The Board formally
  closes hearing and moves into deliberation in an open forum. The Board votes unanimously to uphold ED's recommendation
  to reject Moosehead's 2022 Membership Application. Move; Brenda. Second; Alex. Pass.
