Re: Proposed changes in Application Fees

This memo outlines a proposal to update submittal fees for various applications under Planning Department review. These recommendations reflect the findings of an independent consultant, as described in more detail below.

The Metropolitan Planning Commission is required to provide a recommendation on zoning related fees to the Metropolitan Council (Exhibit A). However, the Metropolitan Planning Commission has final approval on Community Plans and Subdivision related fees (Exhibit B).

The Planning Commission and Council adopted the current fee schedule in 2016. In 2021, Metro retained an independent consultant to determine whether and to what extent fee adjustments are necessary to reflect the current cost and scope of services within various departments. The consultant performed a detailed analysis of such work and determined that fee adjustments are reasonable and necessary. The proposed fee schedules herein are based on the general recommendations of the consultant.

The fees are proposed to become effective July 1, 2022.

Staff recommends approval of the proposed fee structure outlined in Exhibit A and B.
