A. Call to Order & Welcome

The meeting was called to order at 12:08 p.m.

Chair Schmidt recognized the new Commissioners at the meeting and asked them to introduce themselves. He also recognized Paula Roberts and Bonnie Dow whose terms expired and thanked them for their service.

B. Approval of Minutes: February 17, 2022

Chair Schmidt asked if there were any questions or proposed changes to the minutes.

A motion to approve Arts Commission minutes February 17, 2022 was offered by Commissioner Brewer, Commissioner Byrd seconded, and the motion passed.

C. Action Items:

Due to technical difficulties, the Commission started with Actions 3-5.

3. Budget reallocation

Natalie Alfaro Frazier presented the Commission with a staff proposition to reallocate unused Restorative Arts to Thrive and then reallocate excess funds from Thrive to the Diversity in Arts Leadership program (DIAL).

Chair Schmidt asked if there was any questions or discussion.

A motion to approve the reallocation of unused Thrive funds for an additional DIAL intern and the reallocation of unused Restorative Arts funds for 2 additional DIAL interns was offered by Commissioner Byrd, Commissioner Brewer seconded, and the motion passed.

4. DIAL Arts Host Awards

Natalie Alfaro Frazier presented the proposed external arts host organizations for the Diversity in Arts Leadership program:

Chair Schmidt asked if there was any questions or discussion.

The Commission asked for clarification as to why some arts hosts were not chosen, and staff gave clarification.

The Commission expressed concerns and discussed about the interns given Metro Arts' current situation. They asked Metro Arts staff to confirm an eighth arts host for the program.

A motion to approve the proposed Diversity in Arts Leadership Intern Arts Host Awards contingent upon official approval of AFTA agreement amendment, the addition of an eighth external arts host, and the acceptance of both interns and arts hosts was offered by Commissioner Angelico, Commissioner Alvis seconded, and the motion passed.
