**THE FRIENDS OF WARNER PARKS PRESENTS ANNUAL UPDATE TO THE BOARD**

Ms. Jenny Hannon, President of Friends of Warner Parks provided an annual update of activity. Ms. Hannon announced that Friends of Warner Parks is celebrating their thirty-five (35) year partnership between Metro Parks. Highlights of the presentation included: The Friends of Warner Parks has raised \$7.5M of its \$15M capital campaign goal. As of June 2022, \$2.8M has been invested into the Parks for improvements.
