METROPOLITAN NASHVILLE-DAVIDSON COUNTY TRANSPORTATION LICENSING COMMISSION

Minutes April 28, 2022

The Metropolitan Nashville-Davidson County Transportation Licensing Commission (TLC) met for a regular meeting on this date in the Jury Assembly Room of the Historic Davidson County Courthouse. Present were Vice Chair Patrick McNally and Commissioners Mona Lisa Warren, Carey Rogers, Freddie Carr, Michael Hayes, Betsy Williams and Carol Westlake (7). Present were Metro Legal Adviser Tara Ladd with TLC staff members Lisa Steelman, Brandy Brantley, Amanda Mullins, TD Schlafer and Billy Fields.

In the absence of the Chair, the Vice Chair called the meeting to order then led the Pledge of Allegiance followed by a reading of the Notice of Appeal Statement which outlined the right of appeal of TLC decisions.

Commissioner Hayes with a second from Commissioner Warren with a second moved approval of the previous meeting minutes:

The Vice Chair requested to rearrange the agenda to allow business other than public hearings to be taken out of order and there was no objection.

After some discussion with the applicant, Commissioner Rogers with a second from Commissioner Hayes moved to approve.
