Metropolitan Board of Health of Nashville and Davidson County August 11, 2022, Meeting Minutes

The regular meeting of the Metropolitan Board of Health of Nashville and Davidson County was called to order by Chair Tené Franklin at 4:04 p.m. in the Board Room, on the third floor of the Lentz Public Health Center, 2500 Charlotte Avenue, Nashville, TN 37209.

BOARD OF HEALTH

Resolution Honoring Thoris Campbell

Chair Franklin read into the record a resolution honoring Thoris Campbell upon her retirement from the Department (<u>Attachment I</u>).

Approval of July 14, 2022, Meeting Minutes

Mr. Frederick made a motion to approve the July 14, 2022, meeting minutes, as distributed. Dr. Williamson seconded the motion, which passed unanimously.

Monkeypox Update

Dr. Shaw-KaiKai and Rachel Franklin provided an update on Monkeypox outbreak and response (<u>Attachment II</u>). Chair Franklin thanked Dr. Shaw-KaiKai, Ms. Franklin, Dr. Wright, and staff for the Department's efforts in responding to the outbreak. Dr. Shaw-KaiKai recognized the TB Elimination team for their effort in Monkeypox response. Mr. Frederick encouraged the broad-based dissemination of information regarding the response.

Program Presentation: Overview of Tuberculosis Elimination

Dr. Shaw-KaiKai and Billy Reagon provided an update on the Tuberculosis Elimination program, its challenges and staffing issues (<u>Attachment III</u>).

Report of the Director

Dr. Wright referred to the update provided in the Board packet (<u>Attachment IV</u>) and highlighted several elements, including the Health in All Policies (HiAP) Summit: Collaborations for Better Health to be held September 9, 2022, at the downtown public library, and invited Board members to attend.

Dr. Wright invited Laura Varnier to speak briefly on the Red Sand Project, which heightens awareness of human trafficking.

Dr. Wright noted that new Board member Dr. Marie Griffin had been confirmed by Metro Council and would attend the September 8 meeting.

Report of Chair

Chair Franklin recognized Tom Sharp for his prodigious work on the Charter amendments, which had been approved by the voters on August 4, 2022. She mentioned that the Charter will no longer require the director of health to be a medical doctor, and the Board of Health will be expanded to seven members.

Chair Franklin announced that she had attended the National Association of Local Boards of Health conference in Grand Rapids, Michigan, August 1-3, and noted that many directors of health also attend the conference, and that what the department is doing and the courageous conversations the department is having are occurring all over the country to support the public health workforce.

Chair Franklin announced that Board members would be polled regarding potential dates for a retreat.

Chair Franklin noted that Dr. Wright had shared the revised Strategic Plan with Board members and the document would be discussed at the September 8, 2022, Board meeting.

Chair Franklin asked Dr. Wright for a brief update on COVID education messaging, which he provided.

Dr. Smith made a motion to approve the proposed changes to the Medical Doctor Job Description, with the inclusion of doctor of osteopathy to the description. Dr. Williamson seconded the motion, which passed unanimously.

Personnel Changes

Dr. Black referred to the July 2022, Personnel Changes. The changes were extensive due to the position reclassifications as a result of the new pay plan.

Dr. Williamson made a motion to adjourn the Civil Service Board meeting. Vice-Chair Smith seconded the motion, which passed unanimously.
