MS. MARY BYRD, REPRESENTING RECLAIM BROOKMEADE ADDRESSED THE PARKS BOARD REGARDING BROOKMEADE PARK.

Ms. Mary Byrd, representing Reclaim Brookmeade thanked the Parks Board for working to erect a fence. Ms. Byrd advised that conditions at Brookmeade Park have become a crisis and further detailed the current condition of the park. Ms. Byrd asked the Parks Board and the city to do more to improve the condition of the park.

Dr. Steele, thanked Ms. Byrd for her calls, emails, and diligence, and acknowledge her plea. Dr. Steele further informed Ms. Byrd of a special meeting set for September 26, 2022, at 6:00 p.m. at the Bellevue Regional Community Center regarding Brookmeade Park.

Councilmember Sharon Hurt made comments supporting the need to improve conditions at Brookmeade Park, her willingness to assist, and confirmed her attendance at the September 26th meeting.

Director Odom acknowledged that the park had been cleaned multiple times only to fall back into poor condition because there is no permanent solution for outdoor homelessness.

Dr. Sharon Gentry acknowledged the complexity of outdoor homelessness, and the budget implications to repeated clean ups of the parks with no permanent solution in place to improve the conditions.
