2. **CONFIRM QUOROM**

Quorum was confirmed at the meeting's inception.

3. REVIEW AND APPROVAL OF MINUTES

 August 15, 2022 - Requested revisions: add Irwin Venick's statement in public comment; change reference to Larry Turnley's Procurement Board candidacy to from "interview" to "discussion for public comment."

A motion was made, seconded, and adopted to approve the Minutes with revisions.

4. FINANCIAL UPDATE

- MHRC Budget Update
 - Executive Director Davie Tucker explained that MHRC has been approved for two positions one full-time and one part-time. He is researching the possibility of our budget being revised to accommodate making the part-time employee a full-time employee.

Barbara Gunn Lartey explained that "red-font" numerical entries on the report indicate expenditures that were not completed. This typically occurs between budget cycles.

5. **NEW BUSINESS**

Executive Board Elections

 Commissioners Pratik Dash, Jorge Salles Diaz and Ben Tran expressed their interest in serving on the Executive Committee. Executive Director Davie Tucker noted that Maryam Abolfazli and Irwin Venick, also interested, were absent.

Strategic Plan: Initial Planning Discussion

- Executive Director Davie Tucker noted that Board Chair Abolfazli seeks three Executiv0e Board meetings to chart the course for a strategic plan.
- In addition to requesting a list of issues of interest from the Commissioners to be sent to Barbara Gunn Lartey, he enumerated some of the priorities the Commission has recently addressed, including reimagining public safety, wage theft, and affordable housing. Executive Director Tucker referenced the previous plan that amplified advocacy, compliance, and education.

Commissioner Safdie inquired if the strategic plan would be facilitated by someone inhouse or outside consultant. Executive Director Tucker said that he will lead this process.

Executive Director Tucker noted that he wants to individually meet with every Commissioner and will be contacting them to coordinate a time.

6. **OLD BUSINESS**

- Procurement Standards Board Appointment: Action Needed Commissioner Vote
 - Executive Director Tucker explained the need to complete this matter, adding that it has been delayed for several months.

Candidate Larry Turnley expressed his interest in, preparation for, and commitment to serve on the Procurement Standards Board.

- A motion was made and seconded to discuss his procurement nomination.
- After significant discussion ensued, a motion was made. seconded, and adopted to approve Larry Turnley for the Procurement Standards Board.
- Update: Title VI Complaint
 - Executive Director Davie Tucker provided an update on the Title VI Complaints that have been filed with our office. He announced that he is seeking conciliation and will secure outside counsel for these matters. The files are in the office for Commissioner's review.

We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.
