

Metropolitan Board of Health of Nashville and Davidson County October 13, 2022, Meeting Minutes

Chair Franklin assumed the gavel.

Vice-Chair Smith made a motion to approve the grants and contracts. Dr. Williamson seconded the motion, which passed unanimously.

Program Update: Environmental Health

Hugh Atkins and Ivone Rodriguez presented a brief overview of the Environmental Health Bureau and the Food and Public Facilities Protection division (Attachment I).

Report of the Director

Dr. Wright referred to the update provided in the Board packet (Attachment II) and highlighted a few items therein.

Dr. Wright noted that First Lady Dr. Jill Biden had participated in a COVID vaccine promotion event at St. James Missionary Baptist Church on October 12.

Dr. Wright recognized and particularly thanked the Strike Team for their exceptional efforts in planning and staffing pop-up vaccination events.

Report of Chair

Chair Franklin noted that Hispanic Heritage, Breast Cancer Awareness, and National Pregnancy and Infant Loss Awareness, are observed in October. She asked Laura Varnier to especially thank the team who helped organize the Breast Cancer Awareness events.

Chair Franklin reminded the Board that their annual retreat would be held Friday, October 28, and she would be finalizing the agenda soon. She invited them to submit their suggestions for agenda items to Dr. Wright, Dr. Black, or the recording secretary by October 19. [Recorder's note: subsequent to the Oct. 13, 2022 meeting, the retreat was canceled.]

Chair Franklin noted the passing of Dr. Henry W. Foster, Jr., who had served on the Board of Health from 2000-2017, and Vice-Chair from 2001-2004. Ms. Etherington, whose service on the Board coincided with Dr. Foster's, expressed her admiration for him and his service to the city and Department, as well as his keen sense of humor.

Chair Franklin noted that she had attended the Department's Culture Fest on Thursday, September 29, and lauded the organizers for doing a great job, and the participants. She especially noted the diversity of participants, and the strong and enthusiastic attendance.

CIVIL SERVICE BOARD

Public Hearing: Proposed Changes to the Medical Services Director Job Description

Public Hearing: Proposed Changes to Metro Animal Care and Control Positions, and Addition of Behaviorist Position to the Pay Plan

Dr. Black requested deferral of one of the items, Animal Care and Control Office Support Specialist, to a later meeting due to the salary grade being listed incorrectly in the description as SR07 rather than ST07.

Dr. Griffin made a motion to defer consideration of the Animal Care and Control Office Support Specialist to November 10, 2022. Williamson seconded the motion, which passed unanimously.

Dr. Black requested consideration of the Animal Care and Control Program Coordinator – Animal Behaviorist (Attachment V).

Dr. Griffin made a motion to approve the Addition to the Pay Plan of the Job Description Animal Care and Control Program Coordinator – Animal Behaviorist as proposed. Ms. Etherington seconded the motion, which passed unanimously.

Dr. Black requested consideration of the Animal Care and Control Administrative Assistant position (Attachment VI).

Vice Chair Smith made a motion to accept the position as written. Dr. Williamson seconded the motion, which passed unanimously.

Chair Franklin closed the hearing.

<u>Request to Schedule a Public Hearing: Revision to Civil Service Rule 3.2, Selection and Promotional</u> <u>Practices</u>

Dr. Black explained the proposed changes to Civil Service Rule 3.2, Selection and Promotional Practices, that would be presented at a public hearing.
