

**METROPOLITAN NASHVILLE-DAVIDSON COUNTY
TRANSPORTATION LICENSING COMMISSION**

Minutes

October 27, 2022

The Metropolitan Nashville-Davidson County Transportation Licensing Commission (TLC) met for its regular meeting on this date in the Jury Assembly Room of the Historic Davidson County Courthouse. Present were Chair Sal Hernandez with Vice Chair Pat McNally, Commissioners Carey Rogers, Mona Lisa Warren, Carol Westlake and Fred Carr (6). Jason Holleman, representing Night Life Party Tours as well as the applicant Bernard Beene were present. After some discussion, Commissioner Westlake with a second from Commissioners Rogers moved to defer this request indefinitely until or unless a permit becomes available before the February 2023 annual meeting for entertainment transportation.
