A. Call to Order, Welcome, and Land Acknowledgement

Grants and Funding Committee Chair Sheri Bucy and Executive Director Daniel Singh explained that committee and staff have been working closely with our facilitator Dana Parsons to move towards a thoughtful and equitable grant making process. This new direction has been the priority for the grants commission for several years, and the work we've done is built on the feedback and research from final reports we've received for the past several years. The Grants Committee started this process three months ago, and most recently met for 2 and ½ hours this past Monday and thoroughly vetted all aspects. The Grants Committee is unanimously recommending these proposed changes to the full commission. We are going to assume you have read through the packet and will mostly be answering your questions. Grants consultant Dana Parsons, joining the meeting virtually, led the Commission through the proposed changes. Commission engaged in discussion.
