Evaluation Comments

KENNY PIPE & SUPPLY INC.

Strengths - Good overall cost. Good shipping policy and expedited shipping policy. Response to store locations for pickup was adequate. Majority of equipment and parts sold are in stock and in-store. Ability to provide alternate purchasing options during online research was adequate. Respondent's approach for responding to emergency orders was adequate. Company has been in the business for thirty (30) years. List of manufacturers for which respondent is an authorized dealer was adequate.

Weaknesses - Overall Capacity to Perform lacked specific detail. Failed to provide store hours for pickup at each location. Vague response to the backorder process. Response to ability and proposed plan for METRO employees to research materials through the Contractor's on-line system was vague. Failed to explain how the specialized knowledge and experience of the key individuals will be utilized. Response to company's knowledge and capacity in the provision of goods/services related to the scope of work on this contract was boilerplate.
