The decisions of the Metropolitan Beer Permit Board take effect on a date to be determined by the board. However, you may file an appeal within 60 days of the date of entry of the board's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.

Alleged violation of M.C.L 7.08.140C It is unlawful for any beer permit holder or his agent or employee to make or permit to be made any sale of beer to a person under twenty-one years of age. (2nd Offense)

T.C.A 57-5-301(a)(1) prior to making a sale of beer for off-premise consumption, state law requires identification for the sale of beer. (2nd Offense)

M.C.L 7.08.140R It is unlawful for any beer permit holder or his agent or employee to allow or engage in any criminal activity on the premises in violation of Section 39-17-1504 - Sale or distribution to underage persons unlawful - Proof of age requirement - (a) It is unlawful for any person to sell or distribute any tobacco, smoking hemp, or vapor product to another person who has not attained twenty-one (21) years of age or to purchase a tobacco, smoking hemp, or vapor product on behalf of such person under twenty-one (21) years of age. (2nd Offense)

M.C.L 7.08.140R It is unlawful for any beer permit holder or his agent or employee to allow or engage in any criminal activity on the premises in violation of Section 39-17-1504 - Sale or distribution to underage persons unlawful - Proof of age requirement (d) A person engaged in the sale or distribution of tobacco, smoking hemp, or vapor products shall demand proof of age from a prospective purchaser or recipient if an ordinary person would conclude on the basis of appearance that the prospective purchaser or recipient may be under thirty (30) years of age on or about January 17, 2023. (2nd Offense)

BBM 3/22/23 Chairman Taylor read the presented Beer Board Violations. Attorney James Clabo pleads guilty to the presented violations. Mr. Kumar (Owner), Mr. Sengupta (Manager) and Ahmend Abdulrahman (Clerk) were all present for the permit holder. Metro Beer Board Inspector I Amanda Webb was present to provide testimony for the Beer Board. After a brief discussion, Ms. Jarmon made a motion to issue a \$5500 Civil Penalty and 1 Year Probation ending 3/22/24 or 60 Day Suspension and 1 Year Probation Ending 3/22/24. The motion was seconded by Mr. Perlen. The Board voted unanimously in favor of the motion presented. Representatives of Punjab Inc were informed random Beer Board Compliance Checks will be conducted.

(37) ADMINISTRATIVE MATTERS

Mr. Darby discussed the status of the 2023 Annual Privilege Tax Fees. A list of locations with unpaid fees will be presented to the Board at BBM 4/13/22, for citation issuance approval for non-payment of the annual privilege tax fee.

(38) EXECUTIVE DIRECTORS REPORT

Director McDonough presented the revenue report. The Board had no questions.

Director McDonough informed the Board he met with representatives of the Metro Finance Department. They were informed the decrease in civil penalties is a direct reflection of the training Inspectors and Staff are providing to the public.

Board Members request staff add a Beer Buy Compliance Check "Pass or Fail" to hearings to get a look at the history of the locations results during beer buy compliance checks. This will assist in making a more informed recommendation during the penalty phase.

Board Members request Inspectors and Staff research possible training options, when dealing with the public, such as De-escalation Training.
