## APPEAL OF DECISIONS

If you are not satisfied with a decision of the Metropolitan Beer Permit Board regarding your application or your hearing, you may appeal the decision to the Davidson County Chancery or Circuit Court pursuant to the requirements set forth in T.C.A. 57-5-108. The decisions of the Metropolitan Beer Permit Board take effect on a date to be determined by the board. However, you may file an appeal within 60 days of the date of entry of the board's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.

**Following Vice Chairperson Jarmon's reading of the complaints and staff recommendations, Ms. Jarmon made a motion to accept the staff recommendations as read. Mr. Perlen seconded the motion. The Board then voted unanimously to accept the staff recommendations as read.**

(64) DISCUSSION

Mr. Matthew Leff – Special Event Rules

**Matthew Leff requested the Board consider approving Special Event permits to non-profits in situations where the permitted space is under 100ft from a school property if permission was received from the school principal.**

**Metro Legal Counsel, Matthew Garth, informed the Board of our current ordinance that pertains to applying for a council exemption by resolution, 7.08.090 (E)(1), which does not include language for a Special Event. The Chairman, Brian Taylor, discussed the fact that we currently issue Special Event permits for events being held in a Metro Park with approval by Metro Parks even though 7.08.090 specifically says that a permit cannot be issued to a location that is less than 100 ft from a park. He believes we may be able to grant the Special Event permit using similar guidelines. No decision was made at this meeting. More discussion is to follow at the next meeting.**
