### APPEAL OF DECISIONS

If you are not satisfied with a decision of the Metropolitan Beer Permit Board regarding your application or your hearing, you may appeal the decision to the Davidson County Chancery or Circuit Court pursuant to the requirements set forth in T.C.A. 57-5-108. The decisions of the Metropolitan Beer Permit Board take effect on a date to be determined by the board. However, you may file an appeal within 60 days of the date of entry of the board's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.

- (d) The Beer Board utilize a physical sign-up sheet to be made available at the meeting so that those who wish to speak must be present and write their name on the list to indicate that they would like to provide comments to the Beer Board; and

(e) Those who wish to speak must sign up prior to the beginning of the meeting.

Mr. Perlen seconded the motion. The Board voted unanimously to adopt Metro Legal's "Public Comment Period at Meetings" recommendations.
