Team Qualifications and Experience and References section, provided references, gave details about firm being in business for the 10 and 5 years requested. In Functional Requirements, responded to every bullet point and very detailed in the breakdown of the build. In Project Schedule and Capacity to Perform section, provided a good timeline.

Weaknesses

Team Qualifications, Experience and References section, Scope and Size of references missing, key individuals was lacking details. Functional Requirements section, turnaround time for repairs was very vague. Angles of vehcile missing/lacked details. Project Schedule and Capacity to Perform section, factory representative was not specificed.
