2. **CONFIRM QUOROM**

Quorum was confirmed and the meeting was called to order at 4:07 pm.

Director Tucker reported that the staff is working on completing the budget proposal for the Commission's review.

Staff update

RJ Robles' ended his employment with the MHRC. We will work to fill his position as soon as possible.

• Executive Director evaluation

Chair Abolfazli explained the evaluation process. Commissioners were emailed an evaluation form to complete and return to Crystal Cockrill. The Executive Committee will meet on 02/19/2024 to discuss and tally the results. Paper copies of the evaluation form were distributed to the Commissioners as well.

MHRC office move and change of address
 The new office is located at 150 2nd Avenue North.

• Bylaws and Rules Ad hoc Committee update

The committee met in December. Commissioner Traughber explained that the committee met to discuss the amending of the bylaws. They noticed potential gaps with the MHRC's involvement with Title VI investigations. The code also lacked clarity around the Commission's decision making and/or recommendations with complaints. To determine when the rules and procedures were adopted, Commissioner Venick contacted three previous executive directors Carolyn Blackwell, Tom Negri and Mel Fowler-Green. They were adopted in 2012. The committee will meet again to discuss the rules and procedures. Commissioner Traughber explained that the code allows the Commission to revise and adopt rules and procedures as long as they do not exceed the authority given to the MHRC. Attorney Garth agreed and will review the document if amendments are made.

Discussion was made about amending the charter. Attorney Garth stated that the Metro Code contains a general provision for boards and commissions to summon individuals to appear. He will research further to provide clarity to that provision and how it affects the MHRC.

Attorney Garth stated that Metro Legal will send a response soon. Director Tucker acknowledged that a response was received from Metro Legal that did not address the questions in the letter.

Chair Abolfazli stated that the Commission will vote on adopting the complaints report in February.

We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.
