The decisions of the Metropolitan Beer Permit Board take effect on a date to be determined by the board. However, you may file an appeal within 60 days of the date of entry of the board's decision. We advise that you seek your own independent legal advice to ensure that your appeal is filed in a timely manner and that all procedural requirements have been met.

Ms. Glapion requested clarification on why Item #51 was only for a \$1,000 civil penalty versus \$1,500 typically seen in these cases. The Board clarified that this was a sale of liquor to a minor, in which the max penalty that can be given is \$1,000. Further, only sales of beer to a minor can receive a civil penalty greater than \$1,000.
