In Capacity to Perform section, lack of distribution centers, returns not very detailed process. Qualifications and Experience lacked details on previous projects.

In Qualifications and Experience section, did answer all bullet points. In Capacity to Perfrom section, did answer all bullet points

Weaknesses

In Risk Mitigation section, no future issues given, indicating no issues such as national disasters and/or supply chain issues would never occur. In Qualifications and Experience section, lack of equipment, did not respond "Yes" to all items on product list, scope lacked detail. Capacity to Perform section, very vague on bullet points and only had a couple of distribution centers
