Graph 1

Presents information about board membership. There are currently 70 active board, with complete information available for 26 boards and incomplete information for 44 boards. Among the 636 total board seats, 586 are occupied while 50 are unoccupied. Furthermore, there are 696 pending membership applications, with 419 recently submitted and 277 submitted more than six months ago.

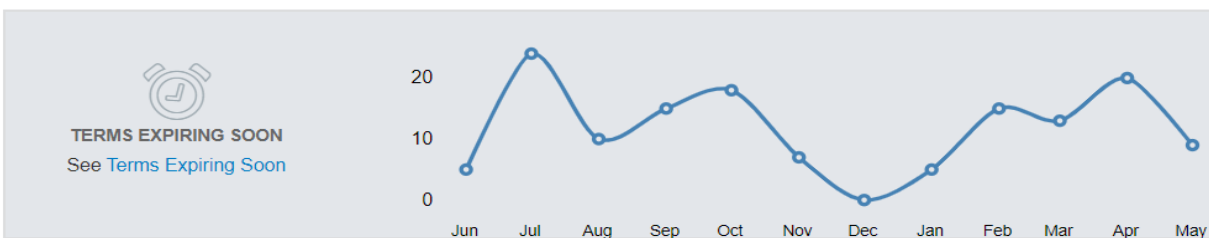

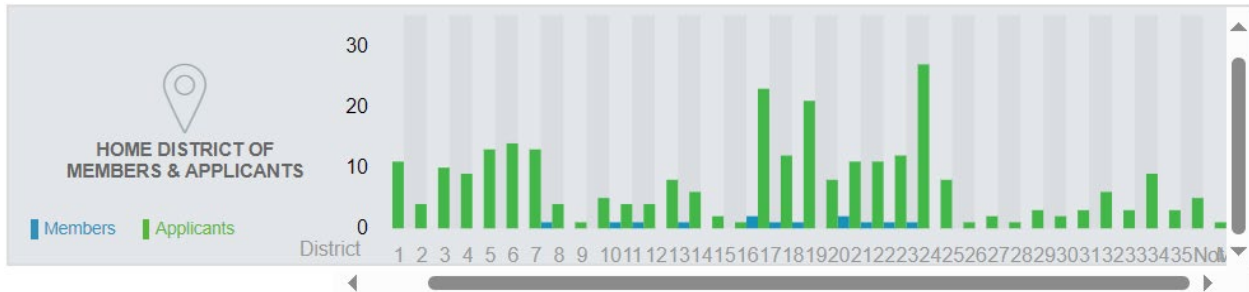
Graph 2

Represents the trend of term expirations over the course of the past year, with the highest number of terms expiring in July and the lowest number in December.

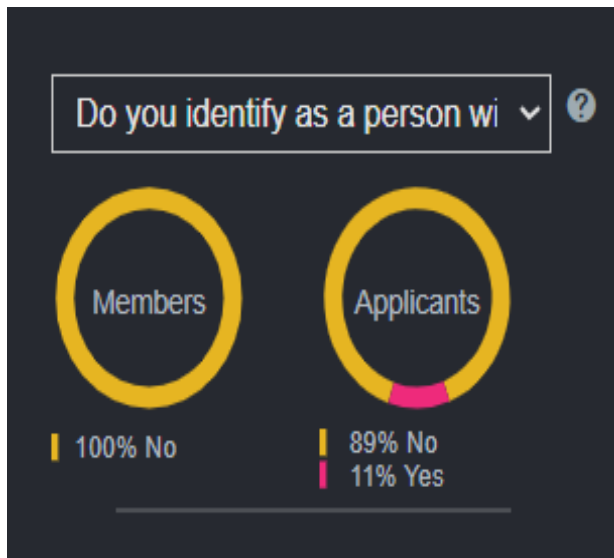

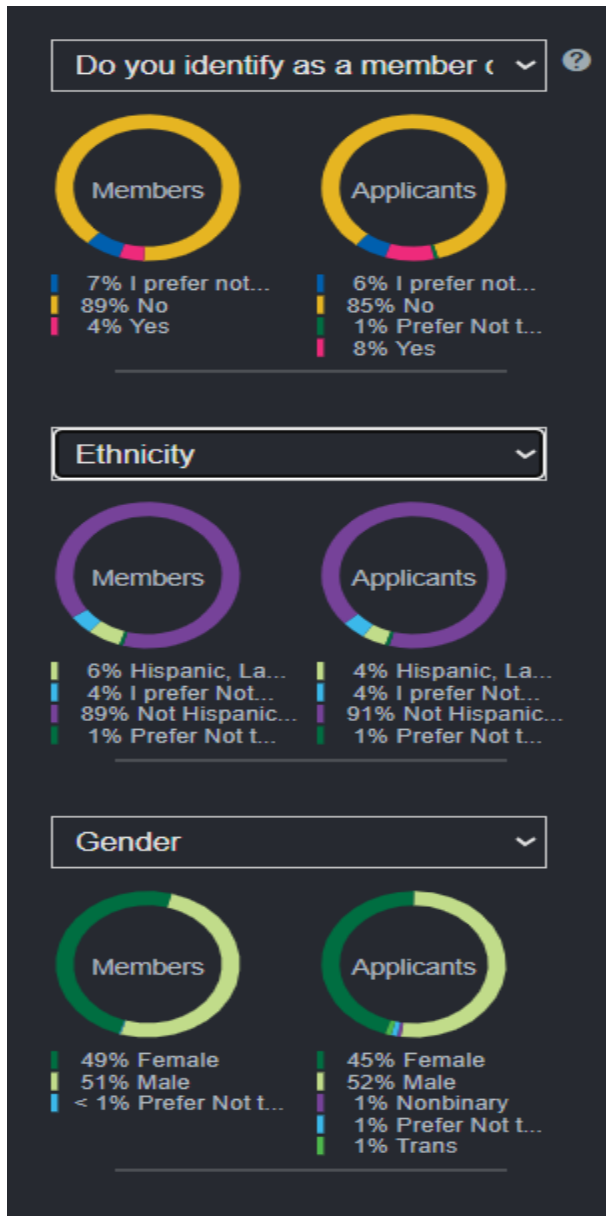

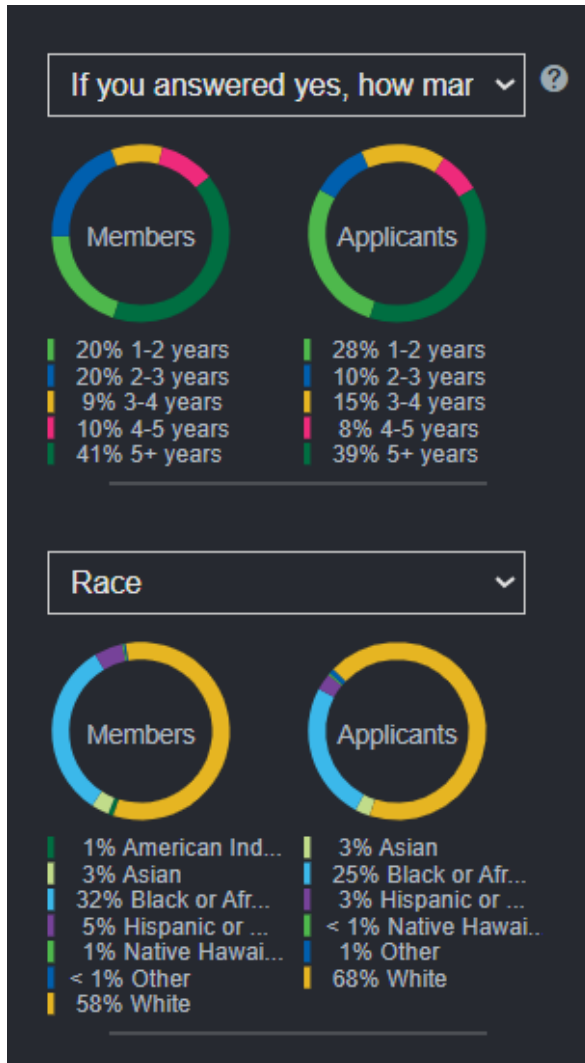


Presents data on LGBTQ+. For Members 7% prefer not to say, 89% do not wish to identify as LGBTQ+, and 4% openly identify as LGBTQ+. For Applicants 7% prefer not to say, 85% do not wish to identify as LGBTQ+, and 8% openly identify as LGBTQ+.

Data on Ethnicity show among members, 6% identify as Hispanic, Latino, or of Spanish origin, 5% prefer not to say, and 89% do not identify as Hispanic, Latino, or of Spanish origin. For applicants, 4% identify as Hispanic, Latino, or of Spanish origin, 5% prefer not to say, and 91% do not identify as Hispanic, Latino, or of Spanish origin.

Data on Gender status show among members 49% identify as female and 51% identify as male, and < 1% prefer not to say. For applicants, 45% identify as female, 52% identify as male, 1% identify as nonbinary, 1% prefer not to say, and 1% identify as transgender.

Presents data on years of service on the Metro Boards and Commission. For members 20% served 1-2 years, 20% 2-3 years, 9% 3-4 years, 10% 4-5 years, 41% 5+ years. For applicants 28% served 1-2 years, 10% 2-3 years, 15% 3-4 years, 8% 4-5 years, 39% 5+ years.

Presents data on Race Group. For members 1% American Indian, 3% Asian, 32% Black or African American, 5% Hispanic or Latino, < 1% Native Hawaiian or Pacific Islander, <1% Other, 58% White. For applicants 3% Asian, 26% Black or African American, 3% Hispanic or Latino, < 1% American Indian, 1% Other, 68% White.
