 Andrew Smith provided background surrounding the intersection and the request. Discussion was had surrounding the intersection. Commissioner Kornutick moved to approve. Commissioner Green seconded the motion. The motion was approved with no objections.

6.1 CD 19: Revocation of parking time restriction, 2-hour maximum from 6AM – 6PM, on the north side of Herman St. between 14th Ave N and 16th Ave N, requested by NDOT.

Emanuel Matyas and Marcus Jackson from NDOT provided background surrounding the request. This item was recently
approved and as a result we are revisiting this, looking for a better solution for the community. Max Caskie speaking on behalf
of CM Kupin. CM Kupin is asking that we revoke the previous decision Commission Green made a motion to approve. Philip
Pearcy with Catalyst Design made the original request and would like to work with the neighbor to find a solution. Discussion
was had surrounding the request, Ms. Costonis clarified Roberts Rules and how they applied to the current request.
Commissioner Green made a motion to rescind the previous motion with the expectation that this is brought back to the
commission in 120 days with a new proposal. Commissioner Gonzales seconded the motion. The motion was deferred with no
objections.

6.2 cd 19: Authorization for 50ft Valet Zone on the west side of 12th Ave N at Grundy St, effective 11AM – 2 PM and 6PM – 12AM/ 7days, requested by Parking Management Company.

 Emanuel Matyas and Marcus Jackson from NDOT provided background surrounding the request. Discussion was had surrounding the request. Andrew Smith provided additional clarification. Commissioner Green made a motion to defer one month. Council Member Evans-Segall seconded the motion. The motion was deferred for one month with no objections.

6.3 CD 18: Removal of existing Valet Zone and authorization for a new 75-ft Passenger Loading Zone, 24/7 on the east side of 20th Ave S at Belcourt Ave, requested by Moxy Nashville Vanderbilt.

Emanuel Matyas and Marcus Jackson from NDOT provided background surrounding the request. Kevin Gangaware and Tom White with SCDG Engineering provided background to the request and the UDO that was created at the time the development was built. The UDO included the two loading zones that were approved as part of the site plan. The intent was for the one loading/valet zone to be used as a loading zone. Greg Averbuch Managing Partner for the Moxy spoke to the agreement with the city, Ms. Costonis clarified that this commission is the only authority that can grant a loading zone. Diana Alarcon spoke to the valet and safety issues at hand. Discussion was had surround the leading zones designated to the Moxy. Council Member Evans moved to adjust the valet lane to 45 feet 24/7 and reassign as a passenger loading zone to be reevaluated in five months and NDOT to provide a plan for the east side of Hillsboro Village. Commissioner Green seconded the motion. The motion was approved with no objection.

Traffic and Parking Commission Authority: Chapter 9 of the Metropolitan Charter, Sec. 11.904. - Function of commission as to traffic regulation.

For the purpose of making the roads, streets and other public ways safe for pedestrians, motorists and others, and for the purpose of facilitating the flow of traffic thereon, the commission is hereby authorized to adopt and publish traffic regulations, including the erection of proper signs necessarily and properly connected with or incident to the following:

(a)The location and time when parking shall be limited.(b)Places where parking shall be prohibited entirely or only during certain hours.(c)The establishment of stop sign controls for through streets or isolated intersections.(d)The establishment of traffic signal controls.(e)The direction in which traffic may use any street or portion of a street. (f)Restrictions on the size of vehicles using certain streets. (g)The establishment of speed zones upon metropolitan streets and roads based upon the findings of the commission. When such zones are properly signposted, the speed indicated on the signs shall be the legal speed limit.

Such traffic regulations adopted by the commission shall take effect five (5) days after they have been published in a daily newspaper of general circulation within the area of the metropolitan government and after a certified copy thereof has been filed with the metropolitan clerk and the chief of police. Such regulations, when so adopted, shall have the force and effect of an ordinance, and shall be enforced by the metropolitan police. The metropolitan council shall provide by ordinance for the punishment of violators of such traffic regulations and shall fix proper and adequate fines and penalties.
